Title.

1. These Rules may be cited as the Permits and Registers Rules.

Permits of entry.

2. Any person may apply, verbally or in writing, to the Principal Immigration Officer for the issue of any entry permit.

Permits of residence.

3. (1) Any person may apply, verbally or in writing, to the Principal Immigration Officer for the issue of a two-day, weekly, fortnightly, monthly or quarterly permit of residence.

(2) Any person seeking an annual permit of residence shall apply there for in writing to the Principal Immigration Officer.

Forms of permits and certificates.

4. Permits and certificates shall be issued in such form as the Principal Immigration Officer may from time to time specify.

Attendance of applicant.

5. (1) The Principal immigration Officer may require any applicant for a permit to attend before him at such time and place as the Principal Immigration Officer may specify.

(2) A person who fails to attend as so required by the Principal Immigration Officer is guilty of an offence and is liable, on summary conviction, to a fine of £25.

Time for application for permit of residence.

6. Any person present in Gibraltar under a valid permit of residence, other than a two-day permit of residence, who seeks a further permit of residence shall apply for the further permit not less than three days before the former permit expires or such application for a further permit shall not be entertained, unless the Principal Immigration Officer otherwise directs in any particular case.

Questions to applicant.

7. (1) The Principal Immigration Officer may ask of any applicant for any permit such questions as he may think fit.

(2) Such questions may be put verbally, or the applicant may be required to complete such form as the Principal Immigration Officer may specify.

Hotel register.

8. The particulars which are required to be kept by the manager or owner of a hotel or lodging house in a registry book, under the provisions of section 56 of the Act shall be those set out in the Schedule and the registry book shall be kept in the form specified in the Schedule.
