**AN ORDINANCE to amend the Town Planning Ordinance and to make
amendments consequential thereto.**

ENACTED by the Legislature of Gibraltar.

Title and commencement

1. (1) This Ordinance may be cited as the Town Planning (Amendment) Ordinance, 1990.

(2) This Ordinance shall come into operation on such day as the Governor may by notice in the Gazette appoint and different days may be so appointed for different purposes.

Amendment to Section 5

2. Section 5 of the Town Planning Ordinance (hereinafter called "the principal Ordinance") is amended—

- (a) by omitting in subsection (2), paragraph (c), the words "Director of Public Works" and substituting therefor the words "Town Planner or such other person as may be appointed for the purpose by the Government";
- (b) by omitting in subsection (4) the words "Director of Public Works" and substituting therefor the words "Town Planner or such other person as may be appointed for the purpose by the Government".

Amendment to Section 13

3. Section 13 of the principal Ordinance is amended—

- (a) by omitting in subsection (2) the words "Director of Crown Lands" and substituting therefor the words "Town Planner or such other person as may be appointed for the purpose by the Government";
- (h) by omitting in subsection (4) the words "Director of Crown Lands" and substituting therefor the words "Town Planner or such other person as may be appointed for the purpose by the Government

Amendment to Section 14

4. Section 14 of the principal Ordinance is amended—

- (a) by omitting in subsection (1) the words "Director of Public Works" and substituting therefor the words "Town Planner or such other person as may be appointed for the purpose by the Government";

- (b) by omitting in subsection (2) the words "Director of Public Works" and substituting therefor "Town Planner or such other person as may be appointed for the purpose ,by the Government".

Amendment to Section 18A

5. Section 18A of the principal Ordinance is amended by omitting in subsection (1) the words "Director of Public Works" and substituting therefor the words "Town Planner or such other person as may be appointed for the purpose by the Government".

Amendment to Section 25.

6. Section 25 of the principal Ordinance is amended by omitting in subsection (1) the word "Governor" and substituting therefor the word "Government".

Amendment to Section 29.

7. Section 29 of the principal Ordinance is amended—

- (a) by omitting the figure "£100" and substituting therefor the figure "£1,000";
- (b) by omitting the figure "£10" and substituting therefor the figure "£100".

Amendment to Section 30.

8. Section 30 of the principal Ordinance is amended—

- (a) by omitting in subsection (1) the word "Governor" and substituting therefor the word "Government";
- (b) by omitting in paragraph (f) of subsection (1) the word "Governor" and substituting therefor the word "Government";
- (c) by omitting subsection (2).

Amendment to Section 31.

9. Section 31 of the principal Ordinance is amended—

- (a) by omitting the figure "(1)";
- (b) by omitting in subsection (1) the word "Governor" and substituting therefore the word "Government";
- (c) by omitting subsection (2)

Amendment to Schedule.

10. The Schedule to the principal Ordinance is amended

- (a) in paragraph 1 by—
 - (i) omitting the figure "(1)";
 - (ii) omitting in subparagraph (1) (b) the word "two" and substituting therefor the word "four";
 - (iii) omitting in subparagraph (1) (d) the semi-colon and substituting therefor a full stop;
 - (iv) omitting subparagraphs (1) (e) and (1) (f);
 - (v) omitting subparagraph (2)
- (b) by omitting in paragraph 4 the words "Director of Crown Lands" and substituting therefor the words "Town Planner or such other person as the Government may appoint for the purpose".

Amendment to the Civil Air Terminal Ordinance.

11. The Civil Air Terminal Ordinance is amended—

- (a) in Section 2 by omitting from the interpretation of "Civil Air Terminal" the words "office of the Director of Crown Lands"

- and substituting therefor the words "offices of the Government";
- (b) in Section 7 by omitting the words "Director of Crown Lands" and substituting therefor the words "Town Planner or such other person as may, be appointed by the Government for that purpose".

Amendment to the Income Tax Ordinance

12. The Income Tax Ordinance is amended in Section 26A by omitting in subsection (5) the words "Director of Crown Lands" where they appear in paragraphs (a) and (b) and substituting therefor the words "Town Planner or such other person as the Government may appoint for the purpose" in each such place.

Amendment to the Land (Acquisition) Ordinance

13. The Land (Acquisition) Ordinance is amended in Section 2 by omitting in the interpretation of "Director" the words "Director of Crown Lands" and substituting therefor the words "Town Planner or such other person as the Government may appoint for this purpose".

Amendment to the Landlord and Tenant Ordinance

14. The Landlord and Tenant Ordinance is amended—
- (a) in Section 5 by omitting
- (i) the figure "(1)";
- (ii) subsection (2);
- (b) in Section 22 by omitting in subsection (3) the words "Director of Crown Lands" and substituting therefor the words "Town Planner or such other person as may be appointed by the Government for this purpose".

Amendment the Public Health Ordinance.

15. (1) The Public Health Ordinance (in this section called "the Ordinance") is amended in section 2 by omitting in ' the interpretation of "public

highways" the words "at the office of the Director of Crown Lands" and substituting therefor the words "in the Offices of the Government".`

(2) Section 44 of the Ordinance is amended by omitting the words "at the office of the Director of Crown Lands" and substituting therefor the Words "in the offices of the Government".

(3) Section 269 of the Ordinance is amended in paragraph (b) by omitting the words "at the office of the Director of Crown Lands" and substituting therefor the words "in the offices of the Government".

(4) Section 271 of the Ordinance is amended in the proviso to subsection (4) by omitting the words "with the Director of Crown Lands" and substituting therefor the words "in the offices of the Government".

(5) Section 279 of the Ordinance is amended by omitting in paragraph. (i) the words "with the Director of Crown Lands" and substituting therefor the words "in the offices of the Government".

(6) Section 293 of the Ordinance is amended in the proviso to subsection (3) by omitting the words "with the Director of Crown Lands" and substituting therefor the words "in the offices of the Government".

(7) Section 301A of the Ordinance is amended in subsection (I) by—

- (a) omitting in paragraph (a) the words "Director of Crown Lands" and substituting therefor the words "Town Planner or such other person as the Government may appoint for the purpose";
- (b) inserting in paragraph (b) after the words "as such" the words "but shall not be associated with the person of the Valuation Officer".

(8) Section 308 of the Ordinance is amended—

- (a) in subsection (1) by—
 - (i) omitting the word "ten" and substituting therefor the word "five"

(ii) by omitting the words "twenty-five pence" and substituting therefor the expression "2 or such other figure as the Government may by notice in the Gazette specify from time to time";

(b) in subsection (2) by omitting the figure "£5" and substituting therefor the figure "£100"

(9) Section 314 of the Ordinance is amended by inserting after the words "the Government" in the two places where these words appear, the words "or such agent as may be appointed by the Government for this purpose".

(10) Section 316 of the Ordinance is amended in subsection (1) by inserting after the word "officer" the words "or agent".

(11) Section 317 of the Ordinance is amended—

(a) in subsection (1) by inserting after the word "officer" the words "or agent";

(b) in subsection (2) by omitting the words "expressed to hold an office by virtue of which he is" and substituting therefor the words "or agent of the Government".

(12) Section 320 of the Ordinance is amended in subsections (1), (2), (3) and (7) by inserting after the word "officer" where it appears in each of these subsections the words "or agent".

Amendment to the Licensing and Fees Ordinance.

16. The Licensing and Fees Ordinance is amended by inserting in Section 37 after the word "Government" the words "or to such person as may be appointed by the Governor by notice in the Gazette,".
