**PARKING SCHEME (ZONE 2)
ESTABLISHMENT ORDER****(LN. 2018/032)**

Commencement **1.3.2018**

In exercise of the powers conferred on him by regulation 8 of the Traffic (Parking and Waiting) Regulations 2011, the Minister has established a Parking Scheme within Zone 2 as set out below—

Title.

1. This Order may be cited as the Parking Scheme (Zone 2) Establishment Order.

Commencement.

2. This Order comes into operation on 1st March 2018.

Parking Scheme.

3. Parking facilities in Zone 2 are divided into 7 types—

1. Residential Parking – Car parking spaces demarcated with yellow road markings and signposts with the words “Zone 2 Resident Permit Holders Only” in which a person who holds a “Zone 2 Residents’ Parking Permit” issued by Gibraltar Carparks Ltd may park. This parking is not to be used to park motorcycles.
2. Pay and Display Parking – Car parking spaces demarcated with blue road markings and signposts with the words “Pay & Display Parking” in which any person will be able to park on payment of a charge by purchasing a ticket from the ticket machine. The ticket must be displayed at the front windscreen in a manner that it can be read from outside the car.

3. Disabled Parking Bay – Car parking spaces demarcated by signposts with the words “Disabled Persons Badge Holders Only” in which a person who holds a “Disabled Person’s Badge” may park.
4. Motorcycle Parking – Motorcycle parking spaces demarcated by signposts in which any person will be able to park.
5. Loading and Unloading Bays – Loading and unloading bays demarcated by signposts with the words “Loading & Unloading Maximum Waiting Time” in which any person may park during the hours, and for the maximum time, stipulated by the sign. These bays will revert to residential parking spaces at the time stipulated by the aforementioned sign and after said time only a person holding a “Zone 2 Residents’ Parking Permit” will be able to park.
6. Commercial Loading and Unloading Bays – Commercial Loading and Unloading bays demarcated by signposts with the words “Commercial Zone Permit Holders Only” in which “Commercial Zone Permit” and “Commercial Ad Hoc Permit” holders may park during the hours, and for the maximum time, stipulated by the sign.
7. Free Parking – Car parking spaces demarcated with white road markings and signposts with the words “Free Parking Car Only”. This parking is not to be used to park motorcycles and will be free of charge.
