AN ACT TO APPROPRIATE SUMS OF MONEY TO THE SERVICE OF THE YEAR ENDING ON THE  $31^{\rm ST}$  DAY OF MARCH 2020.

#### Title and commencement.

1. This Act may be cited as the Appropriation Act 2019 and comes into operation on the day of publication.

#### Consolidated Fund Appropriation of Expenditure 2019/2020.

- 2.(1) The Accountant General may, under the authority of a general warrant issued in accordance with the provisions of the Public Finance (Control and Audit) Act, pay out of the Consolidated Fund of Gibraltar for the period ending 30<sup>th</sup> September 2020, a sum not exceeding £830,760,000.
- (2) The said sum shall be appropriated only to such purposes and shall not exceed such amounts as are set out in Part 1 of the Schedule to this Act.

#### Consolidated Fund Appropriation of Contributions 2019/2020.

- 3.(1) The Accountant General may, under the authority of a general warrant issued in accordance with the provisions of the Public Finance (Control and Audit) Act, pay out of the Consolidated Fund of Gibraltar for the period ending 30<sup>th</sup> September 2020, a sum not exceeding £50,001,000.
- (2) The said sum shall be appropriated only to such purposes and shall not exceed such amounts as are set out in Part 2 of the Schedule to this Act.

# Application of sums voted for Supplementary Provision.

4. Notwithstanding anything contained in the Public Finance (Control and Audit) Act, the Minister responsible for finance may direct by means of a warrant that the whole or any part of the sums appropriated under Head 54 Supplementary Provision shall be applied to any of the other Heads specified in Parts 1 and 2 of the Schedule.

#### Improvement and Development Fund Appropriation of Expenditure 2019/2020.

- 5.(1) The Accountant General may, under the authority of a general warrant issued in accordance with the provisions of the Public Finance (Control and Audit) Act, pay out of the Improvement and Development Fund of Gibraltar for the period ending 30<sup>th</sup> September 2020, a sum not exceeding £104,000,000.
- (2) The said sum shall be appropriated only to such purposes and shall not exceed such amounts as are set out in Part 3 of the Schedule to this Act.

#### **Recurrent Expenditure of Public Undertakings.**

- 6.(1) The Accountant General may, under the authority of a general warrant issued in accordance with the provisions of the Public Finance (Control and Audit) Act, pay out of the Consolidated Fund of Gibraltar for the period ending 30<sup>th</sup> September 2020, a sum not exceeding £426,414,000.
- (2) The said sum shall be appropriated only to such purposes and shall not exceed such amounts as are set out in Part 4 of the Schedule to this Act.

# Capital Expenditure of Public Undertakings.

- 7.(1) The Accountant General may, under the authority of a general warrant issued in accordance with the provisions of the Public Finance (Control and Audit) Act, pay out of the Improvement and Development Fund of Gibraltar for the period ending 30<sup>th</sup> September 2020, a sum not exceeding £16,656,000.
- (2) The said sum shall be appropriated only to such purposes and shall not exceed such amounts as are set out in Part 5 of the Schedule to this Act.

#### Power to amend laws to deal with economic consequences of Covid 19 Pandemic

- 8.(1) The Chief Minister, unless it is not practicable to do so, in consultation with the Leader of the Opposition, shall have power to make any regulations and amend any primary or secondary legislation, as may be necessary to put in place measures to assist businesses, registered employers and employees in the context of the public health emergency created by the Coronavirus Covid 19.
- (2) This power shall only be exercisable for 90 days from the date hereof unless it is extended by Parliament or by the express written agreement of the Chief Minister and the Leader of the Opposition, which agreement shall be tabled in this House at the first sitting of the Parliament after the said agreed extension has been agreed.
