### EXPORT CONTROL (SANCTIONS ETC.) (AMENDMENT NO.8) ORDER 2015

In exercise of the powers conferred upon him by sections 3, 4, 5, 6, 7 and 9 of the Export Control Act 2005, and all other enabling powers, purpose of implementing Council Implementing Regulation (EU) No 2015/1949 of 29 October 2015 concerning restrictive measures in respect of Belarus, the Minister has made the following Order-

#### Title.

1. This Order may be cited as the Export Control (Sanctions etc.) (Amendment No. 8) Order 2015.

### **Commencement.**

2. The Order comes into operation on the date of publication.

### Amendment to Schedule 4.

3. Schedule 4 to the Export Control (Sanctions etc.) Order 2005 is amended after the heading "Belarus"-

- (a) by deleting the following entries for entities-
  - (i) "LLC Triple Metal Trade";
  - (ii) "JV LLC Triple-Techno";
  - (iii) "MSSFC Logoysk"; and
  - (iv) "Triple- Agro ACC"; and

## (b) by replacing the following entries for persons listed-
