1. These Regulations may be cited as the Limited Partnerships (Fees) Regulations 2021.

Commencement.

3. The fee payable to the Registrar in respect of a matter specified in the first column of the Schedule is the corresponding fee specified in the second column of that Schedule.

Revocation.

4. The Limited Partnerships (Fees and Forms) Rules 2013 are revoked.
