EXPLANATORY MEMORANDUM

This Notice amends the Ukraine Sanctions (No.2) Order 2014 for the purpose of implementing Council Implementing Regulation (EU) 2018/1929 of 10 December 2018 implementing Regulation (EU) No 269/2014 concerning restrictive measures in respect of actions undermining or threatening the territorial integrity, sovereignty and independence of Ukraine.
