**Public Health (Exemption from Rates) Order 2018**

*In exercise of the powers conferred upon me by Section 282 of the Public Health Act, and of all other enabling powers, I hereby make the following order –*

**Title.**

1. This order may be cited as the Public Health (Exemptions from Rates) Order 2018.

**Commencement.**

2. This order shall have effect for the rating period commencing on the 1st day of July of 2015 and ending with the 30th day of June 2016.

**Exemption.**

3. The premises specified in Column 2 of the Schedule are, while they are occupied by the persons or bodies specified respectively in Column 1 of the Schedule in relation to those premises and used for the purposes specified respectively in Column 3 of the Schedule in relation to those premises exempt from the payment of rates chargeable thereon to the extent specified respectively in Column 4 of the Schedule in relation to those premises.
