TRADE LICENSING (FORMS) REGULATIONS

Title.

1. These regulations may be cited as the Trade Licensing (Forms) Regulations.

Trading licence.

2.(1) A licence to trade or carry on a business shall be as in Form I of the Schedule.

(2) Where a licence is renewed the licensing authority shall note the fact of such renewal on the licence in such form as it deems appropriate but so as to show the period of renewal and the date of renewal.

Register of licences.

3. The register of licences to be kept by the licensing authority shall be as in Form 2 of the Schedule.

Application for licence.

4. Notice of intention to apply for a licence shall be as in Form 3 of the Schedule.

Objection to licence.

5. Notice of objection to the issue of a licence shall be as in Form 4 of the Schedule.

Form of licence.

6. An application for a licence shall be as in Form 5 of the Schedule.

Duplicate licence.

7. An application for a duplicate licence shall be as in Form 6 of the Schedule.

8.(1) Notice of intention to apply for the transfer of a trade or business to other premises shall be as in Form 7 of the Schedule.

(2) Notice of objection to the transfer of a trade or business to other premises shall be as in Form 8 of the Schedule.
