UKRAINE (TRAVEL RESTRICTIONS) (AMENDMENT) (No.4) REGULATIONS 2014

In exercise of the powers conferred on him by section 52A of the Immigration, Asylum and Refugee Act, the Minister has made the following Regulations–

Title and commencement.

1. These Regulations may be cited as the Ukraine (Travel Restrictions) (No.4) (Amendment) Regulations 2014 and come into operation on the day of publication.

Amendment to Regulation 2.

- 2. In regulation 2 after the words "of Ukraine" insert the following-
 - "as the same may be amended from time to time and reproduced in the Schedule hereto".

Amendment to the Annex.

These Regulations amend the Ukraine (Travel Restrictions) Regulations 2014 for the purposes of implementing Council Decision 2014/499 CFSP of 25 July 2014 and Council Decision 2014/508/CFSP of 30 July 2014.
