*In exercise of the powers conferred on him by regulations 51ZA(1)(c) and (d), 51ZB(2)(b), 51ZC(6B) and 93(3) of the Civil Aviation (Air Navigation) Regulations 2009, the Minister with responsibility for civil aviation has made the following Notice–*

**Title.**

1. This Notice may be cited as the Small Unmanned Aircraft (Miscellaneous Provisions) Notice 2020.

**Commencement.**

2.(1) Paragraphs 3 and 4 of this Notice come into operation on the day of publication.

(2) Paragraphs 5 to 8 of this Notice come into operation on 1 April 2020.

**Interpretation.**

3. In this Notice “the Regulations” means the Civil Aviation (Air Navigation) Regulations 2009.

**Prescribed age for individuals applying for registration as a Small Unmanned Aircraft operator.**

4. Pursuant to regulation 51ZA(1)(c) of the Regulations, the prescribed minimum age for individuals applying for registration as a Small Unmanned Aircraft operator is 18 years.

**Prescribed fee for issuance or renewal of a certificate of registration as a Small Unmanned Aircraft operator.**

5. Pursuant to regulation 51ZA(1)(d) of the Regulations, the prescribed fee for the issuance or renewal of a certificate of registration as a Small Unmanned Aircraft operator is £363.00.

**Prescribed requirements for display of registration numbers on Small Unmanned Aircraft.**

6.(1) Pursuant to regulation 51ZB(2)(b) of the Regulations, the requirements set out in subparagraph (2) are prescribed for the purposes of displaying registration numbers on Small Unmanned Aircraft.

(2) The registration number must be–

- (a) visible from the outside, or within a compartment that can easily be accessed without using a tool;
- (b) clear and in block capitals taller than 3mm;
- (c) secure and safe from damage;
- (d) on the main body of the aircraft.

**Prescribed fee for issuance of an acknowledgement of competency certificate.**

7. Pursuant to regulation 51ZC(6B) of the Regulations, the prescribed fee for the issuance of an acknowledgment of competency certificate is £61.00.

**Prescribed fees for the granting of a permission for the purpose of aerial photography, aerial survey or aerial work.**

8.(1) Pursuant to regulation 93(3) of the Regulations, the prescribed fees for the granting or renewal of a permission for the purposes of aerial photography, aerial survey or aerial work are set out in the Schedule.

(2) The relevant areas listed in the Schedule shall be demarcated in each permission issued.

(3) Where an application for the issue or renewal of a permission is made within two working days of the date on which the permission is required, the prescribed fee shall be three times the amount specified in the Schedule.
