CIVIL CONTINGENCIES ACT 2007

CIVIL CONTINGENCIES EMERGENCY (CORONAVIRUS) (BUSINESSES AND RESTRICTIONS) (NO.8) (AMENDMENT) REGULATIONS

In exercise of the powers conferred on her by section 11 of the Civil Contingencies Act 2007, and all other enabling powers, the Minister with responsibility for Civil Contingencies, acting with the consent of the Chief Minister, has made these Regulations-

Title.

1. These Regulations may be cited as the Civil Contingencies Emergency (Coronavirus) (Businesses and Restrictions) (No.8) (Amendment) Regulations 2020.

Commencement.

2. These Regulations come into operation on the day of publication.

Statement in accordance with section 11(2) of the Act.

- 3. The Minister declares that-
 - (a) there is an outbreak of Coronavirus which on the 11th March 2020 the World Health Organisation (WHO) declared to be a pandemic; at the time of the publication of these Regulations there are more than 20,602,179 confirmed cases globally and more than 1,700,000 people have died; Coronavirus has, to date, reached 235 countries, areas or territories, and it is therefore necessary to take measures to prevent, mitigate and control the spread of Coronavirus in Gibraltar;
 - (b) the conditions in section 12 of the Act are met;
 - (c) these Regulations contain only provisions which are appropriate for the purpose of preventing, controlling or mitigating an aspect or effect of the emergency in respect of which the Regulations are made; and
 - (d) the effect of these Regulations is in due proportion to that aspect or effect of the said emergency.

Amendment to Civil Contingencies Emergency (Coronavirus) (Businesses and Restrictions) (No.8) Regulations 2020.

4.(1) The Civil Contingencies Emergency (Coronavirus) (Businesses and Restrictions) (No.8) Regulations 2020 are amended in accordance with this regulations.

(2) Substitute the following for regulation 5–

"Closure of certain establishments.

- 5.(1) The following establishments must at all times remain closed to any member of the public-
 - (a) discotheques/nightclubs;
 - (b) gymnasiums;
 - (c) restaurants;
 - (d) cafeterias;
 - (e) bars
 - (f) any other establishments that the Minister by notice in the Gazette includes within this Regulation.
- (2) Subregulation (1) does not prevent any establishment from operating a kitchen for the purposes of the sale or supply of food and beverages to consumers for consumption off the premises (that is a takeaway meal) or through a home delivery service provider.
- (3) Subregulation (1)(c) does not apply to-
 - (a) a restaurant in a hotel which only serves food and beverages to the guests of that hotel;
 - (b) the restaurant in the Gibraltar International Airport that is located airside, after passport and security controls; and
 - (c) messing facilities within the Ministry of Defence estate which serve food and beverages to persons entitled to use such facilities (but this does not exempt a bar within that estate).".

(3) In regulation 11–

- (a) in the title delete "Gymnasiums and"
- (b) delete subregulations 1(a), (5), (6), (7), (8), (9), (10) and (13);
- (c) in subregulation (4)(b), delete "(5) or"; and

- (d) in subregulation (11), delete "attending the gymnasium or".
- (4) Delete regulation 12.
