#### LEGAL NOTICE NO. 177 OF 2020

### **CIVIL CONTINGENCIES ACT 2007**

#### CIVIL CONTINGENCIES EMERGENCY (CORONAVIRUS) (HEALTH PROTECTION MEASURES) (UNDER 70s) (AMENDMENT No.2) REGULATIONS 2020

In exercise of the powers conferred on her by section 11 of the Civil Contingencies Act 2007, and all other enabling powers, the Minister with responsibility for Civil Contingencies, acting with the consent of the Chief Minister, has made these Regulations-

#### Title.

1. These Regulations may be cited as the Civil Contingencies Emergency (Coronavirus) (Health Protection Measures) (Under 70s) (Amendment No.2) Regulations 2020.

#### **Commencement.**

2. These Regulations come into operation on the day of publication.

#### Statement in accordance with section 11(2) of the Act.

- 3. The Minister declares that
  - (a) there is an outbreak of Coronavirus which on the 11th March 2020 the World Health Organisation (WHO) declared to be a pandemic; at the time of publication of these Regulations there are more than 3,672,200 confirmed cases globally and more than 254,000 people have died; Coronavirus has, to date, reached 215 countries, areas or territories, and it is therefore necessary to take measures to prevent, mitigate and control the spread of Coronavirus in Gibraltar;
  - (b) she is satisfied, in accordance with section 11 of the Act, that there exists a situation which threatens serious damage to human welfare in Gibraltar and which involves, causes or may cause loss of human life and human illness or injury;
  - (c) on the advice of the Attorney General the measures contained in these Regulations are proportionate and compatible with the Gibraltar Constitution;
  - (d) the conditions in section 12 of the Act are met;

- (e) these Regulations contain only provisions which are appropriate for the purpose of preventing, controlling or mitigating an aspect or effect of the emergency in respect of which the Regulations are made; and
- (f) the effect of these Regulations is in due proportion to that aspect or effect of the said emergency.

# Amendment of the Civil Contingencies Emergency (Coronavirus) (Health Protection Measures) (Under 70s) Regulations 2020.

4. Regulation 4 of the Civil Contingencies Emergency (Coronavirus) (Health Protection Measures) (Under 70s) Regulations 2020 is amended as follows-

- (a) in paragraph (aa) of subregulation (1) delete the words after "business" to the end of the paragraph;
- (b) in subregulation (2)(b) delete the words "no more than three" and replace the full stop at the end of the paragraph with a semi-colon;
- (c) after subregulation (2)(b) insert-
  - "(c) for the purpose set out in (aa) provided that P is alone and, where practicable, practices social distancing from other persons not from the same household.";
- (d) after subregulation (4) insert-

"(4A) Subregulation (2)(c) shall not apply where P is taking a child from the same household to a hair salon and provided that, where practicable, each person practices social distancing from other persons not from the same household.".
