CIVIL CONTINGENCIES ACT 2007

CIVIL CONTINGENCIES EMERGENCY (CORONAVIRUS) (RESTRICTIONS ON GATHERINGS NO. 6) (AMENDMENT) REGULATIONS 2020

In exercise of the powers conferred on her by section 11 of the Civil Contingencies Act 2007, and all other enabling powers, the Minister with responsibility for Civil Contingencies, acting with the consent of the Chief Minister, has made these Regulations-

Title.

1. These Regulations may be cited as the Civil Contingencies Emergency (Coronavirus) (Restrictions on Gatherings No.6) (Amendment) Regulations 2020.

Commencement.

2. These Regulations come into operation on 23rd October 2020.

Statement in accordance with section 11(2) of the Act.

- 3. The Minister declares that
 - (a) there is an outbreak of Coronavirus which on the 11th March 2020 the World Health Organisation (WHO) declared to be a pandemic; at the time of the publication of these Regulations there are approximately more than 40,890,712 confirmed cases globally and around 1,126,351 people have died; the virus has so far reached 235 countries, areas or territories, and it is therefore necessary to take measures to prevent, mitigate and control the spread of the virus in Gibraltar;
 - (b) the conditions in section 12 of the Act are met;
 - (c) on the advice of the Attorney General the measures contained in these Regulations are proportionate and compatible with the Gibraltar Constitution;
 - (d) these Regulations contain only provisions which are appropriate for the purpose of preventing, controlling or mitigating an aspect or effect of the emergency in respect of which the Regulations are made; and
 - (e) the effect of these Regulations is in due proportion to that aspect or effect of the said emergency.

Amendment to the Civil Contingencies Emergency (Coronavirus) (Restrictions on Gatherings No.6) Regulations 2020.

- 4.(1) The Civil Contingencies Emergency (Coronavirus) (Restrictions on Gatherings No.6) Regulations 2020 are amended in accordance with this regulation.
 - (2) In the title to the Regulations, for "NO.6" substitute "AND OTHER MATTERS".
 - (3) In regulation 1, for "No.6" substitute "and Other Matters".
- (4) After regulation 3, insert-

"Part I

Restrictions on Gatherings.".

- (5) In regulation 4, on every occasion that it appears, for "twenty" substitute "sixteen".
- (6) After regulation 4, insert-

"Part II

Other Matters.

Suspension of annual general meetings.

4A.(1) Any –

- (a) legal requirement for; or
- (b) requirement contained in the constitution or rules of,

an organisation to hold an annual general meeting for the year 2020/2021 is suspended until these Regulations expire.

(2) For the purposes of this regulation, "organisation" means a society, union, sports club, social club, cultural club, housing association or charity and includes a club as defined under the Clubs Act.

EXPLANATORY MEMORANDUM

These Regulations amend the Civil Contingencies Emergency (Restrictions on Gatherings No.6) Regulations 2020.
