CIVIL PARTNERSHIP (AMENDMENT OF FEES) REGULATIONS 2025

In exercise of the powers conferred on him by sections 17 and 124 of the Civil Partnership Act 2014, and all other enabling powers, the Minister responsible for personal status has made the following Regulations—

Title.

1. These Regulations may be cited as the Civil Partnership (Amendment of Fees) Regulations 2025.

Commencement.

2. These Regulations come into operation on 1 August 2025.

Amendment of the Civil Partnership (Fees) Regulations 2014.

3.(1) The Civil Partnership (Fees) Regulations 2014 are amended as follows.
