## **COURT OF APPEAL ACT**

### **COURT OF APPEAL (AMENDMENT) RULES 1995**

In exercise of the powers conferred on me by sections 8 and 8A of the Court of Appeal Act, I make the following rules -

#### **1. Title and commencement.**

These rules may be cited as the Court of Appeal (Amendment) Rules 1995 and shall take effect in respect of applications, filings and bonds made on or after the 6th day of March 1995.

#### **2. Amendment to rule 12.**

Rule 12 of the Court of Appeal Rules (hereinafter called “the principal Rules”) is amended by omitting the word “The” and substituting therefor the words “Subject to rule 41, the”.

#### **3. Amendment to rule 13.**

Rule 13 of the principal Rules is amended in sub-rule (1) by omitting the colon and proviso and substituting therefor a fullstop.

#### **4. Revocation and replacement of Schedule 2.**

Schedule 2 to the principal Rules is revoked and replaced with the following new Schedule -

**“SCHEDULE 2**

Rules 12 and 44

**FEES**

**PART I**

The fees set out in this Part and no others shall be taken and paid in respect of all civil causes, matters and proceedings in the court, and in respect of such applications and proceedings in the Supreme Court preparatory or incidental to, or consequential upon, a civil appeal to the court, as are herein specified:

Provided that in all proceedings in the Supreme Court preparatory or incidental to an appeal to the court or consequential thereon, the fees, if not herein specified, shall be in accordance with the provisions of the law applicable to the Supreme Court.

1. Upon filing notice of appeal	£100.00
2. Upon filing notice of cross-appeal	£50.00
3. Upon filing notice of motion (except as under item 5): Provided that where the application is for leave to appeal and leave is granted, credit for this fee is to be given against the fee payable under item 1	£50.00
4. Upon a bond for every party executing the same	£20.00
5. Upon an application for conditional leave to appeal to Her Majesty in Council	£250.00

**PART II**

The fees set out in this Part shall be taken and paid in respect of any appeal falling within Part IV of the rules.

Upon filing notice of appeal	£100.00”.
