EDUCATION ORDINANCE

**EDUCATIONAL AWARDS (AMENDMENT) REGULATIONS
1997**

In exercise of the powers conferred on him by section 82 of the Education Ordinance and section 24 of the Interpretation and General Clauses Ordinance, and of all other enabling powers, the Governor has made the following regulations –

Title and Commencement.

1. These regulations which may be cited as the Educational Awards (Amendment) Regulations 1997 shall be read as one with the Educational Awards Regulations 1990, as amended (a), (hereinafter referred to as the “principal Regulations”) and shall come into effect on the 1st day of September 1997.

Amendment to regulation 15 of the principal Regulations.

2. In regulation 15(1) of the principal Regulations (awards) –

- (a) for the sum “£1188”, there shall be substituted “£1233”; and
- (b) for the sum “£630”, there shall be substituted “£653”.

–

(a) The last relevant amendments were the Education Awards (Amendment) Regulations 1992 (Legal Notice No. 106 of 1992) and the Education Awards (Amendment) Regulations 1994 (Legal Notice No. 89 of 1994).

Amendment to Schedule 2 of the principal Regulations (Statutory Requirements).

3.(1) At Part I of Schedule 2 to the principal Regulations (ordinary maintenance) –

- (a) in paragraph 1, for the rate “£3430”, there shall be substituted “£3636”; and
- (b) in paragraph 2, for the rate “£2790”, there shall be substituted “£2957”.

(2) At Part 2 of Schedule 2 (supplementary and miscellaneous maintenance)-

- (a) in paragraph 1(1)(a), for the sum “£69.25”, there shall be substituted “£86.10p”;
- (b) in paragraph 1(1)(b), for the sum “£51.86”, there shall be substituted “£64.55”;
- (c) in paragraph 4, for the sum “£45.65”, there shall be substituted “£47.36”;
- (d) in paragraph 5, for the sum “£805”, there shall be substituted “£835”;
- (e) in paragraph 7, for the expenditure “£161”, there shall be substituted “£167”;
- (f) in paragraph 8(a), for the rate “£4309”, there shall be substituted “£4569”;
- (g) in paragraph 8(b), for the rate “£3799”, there shall be substituted “£4028”;
- (h) in paragraph 8(c), for the rate “£3292”, there shall be substituted “£3486”; and
- (i) in paragraph 8(d), for the rate “£2790”, there shall be substituted “£2957”.

Amendment to Schedule 3 of the principal Regulations (Resources).

4.(1) In sub-paragraphs 2(1) and (2) of Part 2 of Schedule 3 (parental contributions), for the reference to “£5000”, there shall be substituted “£6000”.

(2) In Part (3) of Schedule 3 (income of spouse) for the reference to “£5000”, there shall be substituted “£6000”.
