EXPORT CONTROL (SANCTIONS ETC.) ORDER 2005

**EXPORT CONTROL (SANCTIONS ETC.)
(AMENDMENT NO.6) ORDER 2015**

In exercise of the powers conferred upon him by sections 3, 4, 5, 6, 7 and 9 of the Export Control Act 2005, and all other enabling powers, and for the purpose of implementing Council Regulation (EU) No 2015/1326 of 31 July 2015 concerning restrictive measures in respect of Belarus, the Minister has made the following Order—

Title.

1. This Order may be cited as the Export Control (Sanctions etc.) (Amendment No.6) Order 2015.

Commencement.

2. This Order comes into operation on the day of publication.

Amendment to Schedule 4.
