NOTICE OF AMENDMENT (NO.21)

In the exercise of the powers conferred upon me by paragraph 3(4) of the Ukraine Sanctions (No.2) Order 2014, I have issued the following Notice-

The Schedule to the Ukraine Sanctions (No.2) Order 2014 is amended as follows-
