## **FAIR TRADING ACT 2023**

## FAIR TRADING (FEES) (AMENDMENT) REGULATIONS 2025

In exercise of the powers conferred upon her by sections 51, 111 and 112 of the Fair Trading Act 2023, the Minister has made the following Regulations—

#### Title.

1. These Regulations may be cited as the Fair Trading (Fees) (Amendment) Regulations 2025.

## Commencement.

2. These Regulations come into operation on 1 August 2025.
