### **Title.**

1. These regulations may be cited as the Fast Launches (Forms, Fees etc.) Regulations, 1987.

### **Forms.**

2.(1) An application for the grant of a licence under section 4 of the Fast Launches (Control) Act, 1987 shall be made in the form FL/1 in the Schedule hereto.

(2) A licence granted under that section shall be in the form FL/2, in the Schedule hereto.

### **Fees.**

3. The fees payable to the Captain of the Port in respect of the different matters provided for in the Act shall be-
