GIBRALTAR COINAGE ACT, 1990.

ISSUE OF WARSHIPS OF WORLD WAR II (DINS NOTICE, 1993.

In exercise of the powers conferred on me by section 2 of the Gibraltar Coinage Act 1990 and of all other enabling powers, I have issued the following notice-

Title.

1. This notice may be cited as the Issue of Warships of World War II Coins Notice, 1993.

Issue of new coins.

2.(1) New coins, in gold, silver, platinum and cupro nickel in the denomination of one Crown and denominations thereof shall be made.

(2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part II of the Schedule to the Gibraltar Coinage Act 1990.

(3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Schedule.

Design of the coins.

3. The design of the coins authorised by this notice shall be as follows-

- (a) the coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH II" to the left and the inscription "GIBRALTAR" and the date of the year to the right;
- (b) the reverse impression shall have on it the design of-

- (i) the USS Gleaves with the Rock of Gibraltar in the background and the inscription "WARSHIPS OF WORLD WAR II. 1 CROWN"; or
- (ii) the HNLNS Isaac Sweers with the Rock of Gibraltar in the background and the inscription "WARSHIPS OF WORLD WAR II. 1 CROWN"; or
- (iii) HMAS Waterhen with the Rock of Gibraltar in the background and the inscription "WARSHIPS OF WORLD WAR II. 1 CROWN"; or
- (iv) USS Philadelphia with the Rock of Gibraltar in the background and the inscription "WARSHIPS OF WORLD WAR II. 1 CROWN"; or
- (v) HMS Penelope with the Rock of Gibraltar in the background and the inscription "WARSHIPS OF WORLD WAR II. 1 CROWN"; or
- (vi) HMS Ark Royal being overflown with the Rock of Gibraltar in the background and the inscription "WARSHIPS OF WORLD WAR II. 1 CROWN"; or
- (vii) FFS Savorgnan de Brazza with the Rock of Gibraltar in the background and the inscription "WARSHIPS OF WORLD WAR II. 1 CROWN"; or
- (viii) HMS Warspite with the Rock of Gibraltar in the background and the inscription "WARSHIPS OF WORLD WAR II. 1 CROWN"; or
- (ix) USS McLanahan with the Rock of Gibraltar in the background and the inscription "WARSHIPS OF WORLD WAR II. 1 CROWN"; or
- (x) HMCS Prescott with the Rock of Gibraltar in the background and the inscription "WARSHIPS OF WORLD WAR II. 1 CROWN"; or

(xi) USS Weehawken with the Rock of Gibraltar in the background and the inscription "WARSHIPS OF WORLD WAR II. 1 CROWN"; or

(xii) HMS Hood with the Rock of Gibraltar in the background and the inscription "WARSHIPS OF WORLD WAR II. 1 CROWN".

Legal tender.

4. The said coins shall be current and legal tender in Gibraltar.
