## GIBRALTAR COINAGE ACT, 1990.

## ISSUE OF THE LABOURS OF HERCULES COIN NOTICE 1994.

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act 1990, and of all other enabling powers, the Governor has issued the following notice -

#### Title.

1. This notice may be cited as the Issue of the Labours of Hercules Coin Notice, 1994.

#### Issue of new coins.

- 2.(1) New coins of-
  - (a) platinum, gold, silver and mixed metal in the denomination of £5, and
  - (b) platinum, gold, silver and cupro nickel in the denomination of a Crown and denominations thereof,

shall be made.

- (2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out -
  - (a) in the case of the £5 coin in Part I of the Schedule to the Gibraltar Coinage Act 1990, and
  - (b) in the case of the Crown and denominations thereof, in Part II of the Schedule to the said Act.
- (3) In the making or the said coins a remedy (that is a variation from the standard weight) shall he allowed as set out in the said Parts of the Schedule.

## Design of the coins.

- 3. The design of the coins authorised by this notice shall be as follows -
  - (a) the coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH II" to the left and the inscription "GIBRALTAR" and the date of the year to the right;
  - (b) the reverse impression shall bear a representation of -
    - (i) Hercules fighting the Nemean Lion with the pillars of Hercules in the background with the inscription "THE LABOURS OF HERCULES THE NEMEAN LION" together with the value of the coin; or
    - (ii) Hercules slaying the nine headed Hydra with the inscription "THE LABOUR OF HERCULES THE LERNEAN HYDRA" together with the value of the coin; or
    - (iii)Hercules wearing his bow and arrow capturing the Ceryneian Hind with the inscription "THE LABOURS OF HERCULES THE CERYNEIAN HIND" together with the value of the coin; or
    - (iv) Hercules binding the Boar in chains with the inscription "THE LABOURS OF HERCULES THE ERYMANTHIAN BOAR" together with the value of the coin; or
    - (v) Hercules cleaning the Stables by diverting the river with the inscription "THE LABOURS OF HERCULES THE AUG-EIAN STABLES" together with the value of the coin; or
    - (vi) Hercules shooting with a bow and arrow at the Stymphalion Birds with the inscription "THE LABOURS OF HERCULES THE STYMPHALION BIRDS" together with the value of the coin; or

- (vii) Hercules fighting the Cretan Bull with the inscription "THE LABOURS OF HERCULES THE CRETAN BULL" together with the value of the coin; or
- (viii) Diomedes being fed to his flesh eating mares who are being held by Hercules with the inscription "THE LABOURS OF HERCULES THE MARES OF DIOMEDES" together with the value of the coin; or
- (ix) Hyppolyte giving her girdle to Hercules, with the Pillars of Hercules in the background and the inscription "THE LABOURS OF HERCULES THE GIRDLE OF HYPPOLYTE" together with the value of the coin; or
- (x) Hercules kills the three bodied monster with a single arrow and holding the Geryon Cattle with the inscription "THE LABOURS OF HERCULES THE CATTLE OF GERYON" together with the value of the coin; or
- (xi) Hercules holding up the earth with the help of Athena while Atlas brings the apples with the inscription "THE LABOURS OF HERCULES THE APPLES OF THE HESPERIDES" together with the value of the coin; or
- (xii) Hercules capturing Cerberus with the inscription "THE LABOURS OF HERCULES CERBERUS" together with the value of the coin.

# Legal tender.

4. The said coins shall be current and legal tender in Gibraltar.
