GIBRALTAR COINAGE ACT 1990

ISSUE OF CLASSICAL HEADS CROWN COIN NOTICE 1997

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act 1990, and of all other enabling powers, the Governor has issued the following notice —

Title.

1. This notice may be cited as the Issue of Classical Heads Crown Coin Notice 1997.

Issue of new coins.

- 2. (1) New coins of platinum, gold, silver and cupro nickel in the denomination of a Crown and denominations thereof shall be made.
- (2) In the making of the said coins, the millesimal fineness, or composition of metals, diameters, shapes and other specifications shall be as set out in Part II of the Schedule to the Gibraltar Coinage Act 1990.
- (3) In the making of the said coins, a remedy (that is, a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins.

- 3. The design of the coins authorised by this notice shall be as follows
 - (a) the coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH II" to the left and the inscription "GIBRALTAR" and the date of the year to the right;
 - (b) the reverse impression shall bear —

- (i) a design of the head of Nefertiti together with the inscription "NEFERTITI and the value of the coin; or
- (ii) a design of the head of Juno together with the inscription "JUNO" and the value of the coin; or
- (iii) a design of the head of Europa together with the inscription "EUROPA" and the value of the coin; or
- (iv) a design of the head of Liberty wearing a helmet together with the inscriptions "LIBERTY" and "FRANCE" and the value of the coin; or
- (v) a design of the head of Arethusa with dolphins circling together with the inscription "ARETHUSA" and the value of the coin; or
- (vi)a design of the head of Liberty wearing a wreath together with the inscription "LIBERTY USA" and the value of the coin; or
- (vii) a design of the head of Britannia with sea and a lighthouse in the background together with the inscription "BRITANNIA" and the value of the coin; or
- (viii) a design of the head of Athena together with the inscription "ATHENA" and the value of the coin; or
- (ix)a design of the head of Cleopatra together with the inscription "CLEOPATRA" and the value of the coin; or
- (x) a design of the head of Ceres together with the inscription "CERES" and the value of the coin.

Legal tender.

4. The said coins shall be current and legal tender in Gibraltar.
