GIBRALTAR COINAGE ACT 1990

ISSUE OF WONDERS OF THE WORLD CROWN COIN NOTICE 1997

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act 1990, and of all other enabling powers, the Governor has issued the following notice —

Title.

1. This notice may be cited as the Issue of Wonders of the World Crown Coin Notice 1997.

Issue of new coins.

- 2. (1) New coins of platinum, gold, silver and cupro nickel in the denomination of a Crown and denominations thereof shall be made.
- (2) In the making of the said coins, the millesimal fineness, or composition of metals, diameters, shapes and other specifications shall be as set out in Part II of the Schedule to the Gibraltar Coinage Act 1990.
- (3) In the making of the said coins, a remedy (that is, a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins.

- 3. The design of the coins authorised by this notice shall be as follows
 - (a) the coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH II" to the left and the inscription "GIBRALTAR" and the date of the year to the right;

- (b) the reverse impression shall bear
 - (i) a design of the figure of Hercules behind the outline of the Rock of Gibraltar and the African coast with two stone pillars in the background with, in the foreground, a depiction of a gold coin on which is depicted the head of the deified Alexander the Great sprouting the Horn of Mammon dating from 336 BC together with the inscriptions "WONDERS OF THE WORLD", "THE PILLARS OF HERCULES", "GIBRALTAR" and "N. AFRICA" and the value of the coin; or
- (ii) a design of the Matterhorn mountain with, in the foreground, a depiction of the 1984 1000 Francs gold coin depicting William Tell together with the inscriptions "WONDERS OF THE WORLD" and "THE MATTERHORN SWITZERLAND — ITALY" and the value of the coin; or
- (iii) a design of the Uluru with an aboriginal figure holding a spear and boomerang with, in the foreground, a depiction of the 1853 Port Philip Australian pattern gold sovereign depicting a kangaroo together with the inscriptions "WONDERS OF THE WORLD" and "ULURU AUSTRALIA" and the value of the coin; or
- (iv) a design of Mount Fuji with, in the foreground, a depiction of the first Japanese gold coin, dated 1870 for the value of 20 Yen, together with the inscriptions "WONDERS OF THE WORLD" and "MOUNT FUJI JAPAN" and the value of the coin; or
- (v) a design of the Niagara Falls with, in the foreground, a depiction of the first Gold Eagle \$10 gold coin, dated 1795, together with the inscriptions "WONDERS OF THE WORLD" and "NIAGARA FALLS CANADA USA" and the value of the coin; or
- (vi) a design of the Guilin Hills with, in the foreground, a depiction of the 1 Liang gold coin, dated 1906, together with the inscriptions "WONDERS OF THE WORLD" and "GUILIN HILLS CHINA" and the value of the coin; or

- (vii) a design of the Taroko Gorge with, in the foreground, a depiction of the Sun Yat-sen centenary gold \$1000 coin, dated 1906, together with the inscriptions "WONDERS OF THE WORLD" and "TAROKO GORGE TAIWAN" and the value of the coin; or
- (viii) a design of a figure of Colossus of Rhodes against a background of the port of Rhodes with, in the foreground, a depiction of the Greek Rose gold coin, dated 400 BC, together with the inscriptions "WONDERS OF THE WORLD" and "THE COLOSSUS OF RHODES" and the value of the coin; or
- (ix) a design of the Pharos of Alexandria against a background of the sea and moon with, in the foreground, a depiction of the first gold coinage of Ptolemy II depicting Desea his wife, together with the inscriptions "WONDERS OF THE WORLD" and "THE PHAROS OF ALEXANDRIA" and the value of the coin; or
- (x) a design of the Hanging Gardens of Babylon with, in the foreground, a depiction of the gold coin Cylinder Seal depicting a boar as the image of Babylon, together with the inscriptions "WONDERS OF THE WORLD" and "THE HANGING GARDENS OF BABYLON" and the value of the coin; or
- (xi) a design of the Mausoleum at Halicarnassus against a background of trees with, in the foreground, a depiction of the gold coin depicting the sun god Helios, together with the inscriptions "WONDERS OF THE WORLD" and "THE MAUSOLEUM AT HALICARNASSUS" and the value of the coin; or
- (xii) a design of the Pyramids of Egypt with, in the foreground, a depiction of the Cleopatra silver coin dated 30 BC, together with the inscriptions "WONDERS OF THE WORLD" and "THE PYRAMIDS OF EGYPT" and the value of the coin; or
- (xiii) a design showing the statue of Zeus-Olympia with, in the foreground, a depiction of a Greek Zeus gold coin dated 300 BC, together with the inscriptions "WONDERS OF THE

WORLD" and "THE STATUE OF ZEUS-OLYMPIA" and the value of the coin; or

(xiv) a design showing the Temple of Diana at Ephesus Turkey with, in the foreground, a depiction of a gold coin of Ephesus, together with the inscriptions "WONDERS OF THE WORLD" and "THE TEMPLE OF ARTEMIS AT EPHESUS" and the value of the coin.

Legal tender.

4. The said coins shall be current and legal tender in Gibraltar.
