#### GIBRALTAR COINAGE ACT

#### YEAR OF THE OCEAN CROWN COIN NOTICE 1998

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act 1990 and of all other enabling powers, the Governor has issued the following notice -

#### Title.

1. This notice may be cited as the Year of the Ocean Crown Coin Notice 1998.

## Issue of new coin.s

- 2.(1) New coins of platinum, gold, silver and cupro-nickel in the denomination of a crown and denominations thereof shall be made.
- (2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part II of the Schedule to the Gibraltar Coinage Act 1990.
- (3) In the making of the said coins, a remedy (that is, a variation of the standard weight) shall be allowed as set out in the said Part of the Schedule.

## Design of the coins

- 3. The design of the coins authorised by this notice shall be as follows -
  - (a) the coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH II" to the left and the inscription "GIBRALTAR" and the date of the year "1998" to the right;
  - (b) the reverse impression shall bear -

- (i) a design of a polar bear and a walrus with her cub on an ice floe together with the inscription "YEAR OF THE OCEAN" and the value of the coin; or
- (ii) a design of a mermaid playing with a dolphin with fishes swimming around together with the inscription "YEAR OF THE OCEAN" and the value of the coin; or
- (iii) a design of a seal with her cub and two penguins on an ice floe together with the inscription "YEAR OF THE OCEAN" and the value of the coin; or
- (iv) the design of a sea cow swimming with her cub together with the inscription "YEAR OF THE OCEAN" and the value of the coin; or
- (v) a design of a coral reef with fish and an octopus together with the inscription "YEAR OF THE OCEAN" and the value of the coin; or
- (vi) a design depicting a cariety of fish including a stingray and a jelly fish together with the inscription "YEAR OF THE OCEAN" and the value of the coin;
- (vii) a design of two windsurfers in movement across the sea together with the inscription "YEAR OF THE OCEAN" and the value of the coin; or
- (viii) a design of a board surfer riding a wave together with the inscription "YEAR OF THE OCEAN" and the value of the coin.

### Legal tender.

4. The said coins shall be current and legal tender in Gibraltar.
