GIBRALTAR COINAGE ACT, 1990

QUEEN ELIZABETH THE QUEEN MOTHER COIN NOTICE, 1998

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Governor has issued the following notice -

Title

1. This notice may be cited as the Queen Elizabeth the Queen Mother Coin Notice, 1998.

Issue of new coins

- 2.(1) New coins of platinum, gold. silver and cupro nickel in the denomination of a Crown and denominations thereof shall be made.
- (2) In the making of the said coins, the millesimal fineness, or composition of metals, diameters, shapes and other specifications shall be as set out in Part II of the Schedule to the Gibraltar Coinage Act, 1990.
- (3) In the making of the said coins a remedy (that is, a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins

- 3. The design of the coins authorised by this notice shall be as follows -
 - (a) the coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH II" to the left and the inscription "GIBRALTAR" and the date of the year to the right;
 - (b) the reverse impression shall bear -
 - (i) the design of a portrait of Lady Elizabeth Bowes-Lyon as a young girl in 1905 with the inscriptions

"THE LIFE OF QUEEN ELIZABETH THE QUEEN MOTHER" and "1905" together with the value of the coin; or

- (ii) the design of a portrait of Lady Elizabeth Bowes-Lyon in 1918 with a veteran of World War I with the inscriptions "THE LIFE OF QUEEN ELIZABETH THE QUEEN MOTHER" and "WORLD WAR I -GLAMIS" and "1918" together with the value of the coin; or
- (iii) the design of a portrait of the Duchess of York on her Wedding Day in 1923 with her Husband His Royal Highness the Duke of York with the inscriptions "THE LIFE OF QUEEN ELIZABETH THE QUEEN MOTHER" and "A ROYAL MARRIAGE" and "1923" together with the value of the coin; or
- (iv) the design of a family portrait in 1936 of the Duke and Duchess of York and their Royal Highnesses the Princesses Elizabeth and Margaret with the dogs and with the inscriptions "THE LIFE OF QUEEN ELIZABETH THE QUEEN MOTHER" and "A ROYAL FAMILY" and "1936" together with the value of the coin; or
- (v) the design of a portrait of Her Majesty Queen Elizabeth on her Coronation in 1937 as Queen Consort with the inscriptions "THE LIFE OF QUEEN ELIZABETH THE QUEEN MOTHER" and "CROWNED QUEEN CONSORT" and "1937" together with the value of the coin; or
- (vi) the design of a portrait of Her Majesty Queen Elizabeth on the State Visit to France in 1938 with the inscriptions "THE LIFE OF QUEEN ELIZABETH THE QUEEN MOTHER" and "STATE VISIT TO FRANCE" and "1938" together with the value of the coin; or
- (vii) the design of a portrait of Their Majesties King George VI and Queen Elizabeth in 1940 in the

grounds of Buckingham Palace inspecting bomb damage during World War II with the inscriptions "THE LIFE OF QUEEN ELIZABETH THE QUEEN MOTHER" and "LONDON BOMBINGS" and "1940" together with the value of the coin; or

- (viii) the design of a portrait of Their Majesties King George VI and Queen Elizabeth with Their Royal Highnesses the Princesses Elizabeth and Margaret in 1945 on the balcony of Buckingham Palace celebrating the end of World War II with the inscriptions "THE LIFE OF QUEEN ELIZABETH THE QUEEN MOTHER" and "VICTORY" and "1945" together with the value of the coin; or
- (ix) the design of a portrait of Her Royal Highness Queen Elizabeth the Queen Mother at the Coronation of Her Majesty Queen Elizabeth II in 1953 with His Royal Highness Prince Philip in the background with the inscriptions "THE LIFE OF QUEEN ELIZABETH THE QUEEN MOTHER" and "THE CORONATION" and "1953" together with the value of the coin; or
- (x) the design of a portrait of Her Royal Highness Queen Elizabeth the Queen Mother in 1954 with her first grandchild His Royal Highness Prince Charles with the inscriptions "THE LIFE OF QUEEN ELIZABETH THE QUEEN MOTHER" and "FIRST GRANDCHILD" and "1954" together with the value of the coin; or
- (xi) the design of a portrait of Her Royal Highness Queen Elizabeth the Queen Mother in 1966 trout fishing in New Zealand with the inscriptions "THE LIFE OF QUEEN ELIZABETH THE QUEEN MOTHER" and "TROUT FISHING N. ZEALAND" and "1966" together with the value of the coin; or
- (xii) the design of a portrait of Her Royal Highness Queen Elizabeth the Queen Mother in 1982 holding her great-grandchild His Royal Highness Prince William

at his Christening together with his mother Her Royal Highness Diana Princess of Wales with the inscriptions "THE LIFE OF QUEEN ELIZABETH THE QUEEN MOTHER" and "CHRISTENING OF WILLIAM" and "1982" together with the value of the coin.

Legal Tender

4. The said coins shall be current and legal tender in Gibraltar.
