LEGAL NOTICE NO. 78 OF 2004

GIBRALTAR COINAGE ACT, 1990

ISSUE OF THE HISTORY OF THE ROYAL MARINES COLLECTION COIN NOTICE, 2004

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act 1990, and of all other enabling powers, the Governor has issued the following notice–

Title.

1. This notice may be cited as the Issue of the History of the Royal Marines Collection Coin Notice, 2004.

Issue of new coins.

2.(1) New coins of gold, silver and cupro-nickel in the denomination of 50 pence shall be made.

(2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part I of the Schedule to the Gibraltar Coinage Act 1990.

(3) In the making of the said coins, a remedy (that is a variation from the standards weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins.

- 3. The design of the coins authorised by this notice shall be as follows
 - the coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH II" to the left and the inscription "GIBRALTAR" and the date of the year to the right;
 - (b) the reverse impression shall bear-

(i) a design that features the Royal Marines, who captured Gibraltar in 1704, in a boat with the Rock of Gibraltar behind them, and the inscription "GIBRALTAR 1704" and the value of the coin;

(ii) a design that features the Royal Marines, firing from a ship at the battle fought and won on 'The Glorious First of June', and the inscription "GLORIOUS 1ST OF JUNE 1794" and the value of the coin;

(iii) a design that features the Royal Marines during the Crimean War, when Britain joined forces with the French to halt Russia's attack on the Turkish Empire, and the inscription "SIEGE OF SEBASTOPOL 1854" and the value of the coin;

(iv) a design that features the Royal Marines engaged in battle on land during the First World War, and the inscription "WORLD WAR I 1914 – 1918" and the value of the coin;

(v) a design that features the Royal Marines engaged in battle on land during the Second World War, and the inscription "WORLD WAR II 1939 – 1945" and the value of the coin;

(vi) a design that features the Royal Marines who played a vital role in the brief but bloody Falklands conflict, and the inscription "THE FALKLANDS 1982" and the value of the coin.

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
