### **GIBRALTAR COINAGE ACT 1990**

# ISSUE OF HER MAJESTY QUEEN ELIZABETH II 80<sup>TH</sup> BIRTHDAY COIN NOTICE 2005

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act 1990, and of all other enabling powers, the Governor has issued the following notice—

# Title.

1. This notice may be cited as the Issue of Her Majesty Queen Elizabeth II  $80^{\rm th}$  Birthday Coin Notice 2005.

#### Issue of new coins.

- 2. (1) New coins of gold, silver and cupro-nickel in the denomination of £10, £5, £1 and crown shall be made.
- (2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part II and Part III of the Schedule to the Gibraltar Coinage Act 1990.
- (3) In the making of the said coins, a remedy (that is, a variation from the standards weight) shall be allowed as set out in the said Parts of the Schedule.

## Design of the coins.

- 3. The design of the coins authorised by this notice shall be as follows-
  - (a) each coin shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH II" to the left and the inscription "GIBRALTAR" and the year 2006 to the right;
  - (b) the reverse impression shall bear–

- (i) a design that features Her Majesty the Queen as a child. Included on the coin are the inscriptions "80 GLORIOUS YEARS" and the value of the coin;
- (ii) a design that features Her Majesty the Queen as a young woman. Included on the coin are the inscriptions "80 GLORIOUS YEARS" and the value of the coin;
- (iii) a design that features Her Majesty the Queen as a grandmother. Included on the coin are the inscriptions "80 GLORIOUS YEARS" and the value of the coin;
- (iv) a design that features a current portrait of Her Majesty the Queen. Included on the coin are the inscriptions "80 GLORIOUS YEARS" and the value of the coin;
- (v) a design that features four portraits of Her Majesty the Queen with a diamond insert in the centre of the coin. Included on the coin are the inscriptions "80 GLORIOUS YEARS" and the value of the coin;
- (vi) a design that features four portraits of Her Majesty the Queen with the Royal cypher EIIR in the centre of the coin. Included on the coin are the inscriptions "80 GLORIOUS YEARS" and the value of the coin;

# Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
