LEGAL NOTICE NO. 93 OF 2006.

**GIBRALTAR COINAGE ACT, 1990**

**ISSUE OF THE ROYAL DECADES COIN NOTICE 2006**

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act 1990, and of all other enabling powers, the Governor has issued the following notice—

**Title.**

1. This notice may be cited as the Issue of The Royal Decades Coin Notice 2006.

**Issue of new coins.**

2.(1) New coins of gold, silver and cupro-nickel in the denomination of £10, £5 and crown shall be made.

(2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part II and Part III of the Schedule to the Gibraltar Coinage Act 1990.

(3) In the making of the said coins, a remedy (that is a variation from the standards weight) shall be allowed as set out in the said Part of the Schedule.

**Design of the coins.**

3. The design of the coins authorised by this notice shall be as follows—

- (a) the coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription “ELIZABETH II” to the left and the inscription “GIBRALTAR” and the date of the year to the right;
- (b) the reverse impression shall bear—

- (i) a design featuring Her Majesty the Queen at her christening in 1926 with the future King George VI and Queen Elizabeth. Included on the coin are the inscriptions “80 GLORIOUS YEARS 1926 – 1936” and the value of the coin;
- (ii) a design featuring Her Majesty the Queen as a young woman making her first radio broadcast in 1940. Included on the coin are the inscriptions “80 GLORIOUS YEARS 1937 – 1946” and the value of the coin;
- (iii) a design featuring Her Majesty the Queen at her Coronation in 1953. Included on the coin are the inscriptions “80 GLORIOUS YEARS 1947 – 1956” and the value of the coin;
- (iv) a design featuring Her Majesty the Queen with her family. Included on the coin are the inscriptions “80 GLORIOUS YEARS 1957 – 1966” and the value of the coin;
- (v) a design featuring Her Majesty the Queen at Prince Charles' Investiture in 1969. Included on the coin are the inscriptions “80 GLORIOUS YEARS 1967 – 1976” and the value of the coin;
- (vi) a design featuring Prince William and Harry, and a cameo of Her Majesty the Queen. Included on the coin are the inscriptions “80 GLORIOUS YEARS 1977 – 1986” and the value of the coin;
- (vii) a design featuring Her Majesty the Queen during the last Trooping of the Colour that the Queen rode a horse at in 1988. Included on the coin are the inscriptions “80 GLORIOUS YEARS 1987 – 1996” and the value of the coin;
- (viii) a design featuring Her Majesty the Queen during her Golden Jubilee. Included on the coin are the inscriptions “80 GLORIOUS YEARS 1997 – 2006” and the value of the coin.

**Legal Tender.**

4. The said coins shall be current and legal tender in Gibraltar.
