GIBRALTAR COINAGE ACT, 1990

ISSUE OF THE HISTORY OF GREAT BRITAIN COIN NOTICE 2009

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for Finance has issued the following notice—

Title.

1. This notice may be cited as the Issue of the History of Great Britain Coin Notice 2009.

Issue of new coins.

- 2.(1) New coins of gold, silver, cupro-nickel and silver-plated cupro-nickel in the denomination of £10, £5, £1 and One Crown shall be made.
- (2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part II and Part III of the Schedule to the Gibraltar Coinage Act, 1990.
- (3) In the making of the said coins, a remedy (that is a variation from the standards weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins.

- 3. The design of the coins authorised by this notice shall be as follows-
 - (a) the coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH II" to the left and the inscription "GIBRALTAR" and the date of the year to the right;
 - (b) the reverse impression shall bear-

- (i) a design featuring The Battle of Hastings, based on a scene from the Bayeux Tapestry, with a cameo inset depicting William the Conqueror. The inscriptions include 'The Battle of Hastings' and the value of the coin.
- (ii) a design featuring King John signed the Magna Carta at Runnymede, with a cameo inset depicting the Magna Carta manuscript. The inscriptions include 'The Magna Carta' and the value of the coin.
- (iii) a design featuring the murder of Wat Taylor (leader of the Peasants' Revolt) while King Richard II addresses the crowds, with a cameo of Richard II. The inscriptions include 'The Peasants' Revolt' and the value of the coin.
- (iv) a design featuring one of the Wars of the Roses (Battle of St Albans), with a cameo symbolising the red and white roses of the Houses of Lancaster and York. The inscriptions include 'The War of the Roses' and the value of the coin.
- (v) a design featuring King Henry VIII, with a cameo depicting his Ship, The Mary Rose. The inscription includes 'Henry VIII' and the value of the coin.
- (vi) a design featuring Queen Elizabeth I with the Spanish Armada and Shakespeare's Globe Theatre in the background. The cameo depicts the initials of Elizabeth I. The inscriptions include 'The Elizabethan Era' and the value of the coin.
- (vii) a design featuring Charles I and Oliver Cromwell, together with a cameo depicting the hats of the Cavaliers and Roundheads. The inscriptions include 'The English Civil War' and the value of the coin.
- (viii) a design featuring the Great Fire of London in 1666, with a quote of Samuel Pepys written in his diary during the fire, plus a cameo depicting Samuel Pepys.

The inscriptions include 'The Great Fire of London' and the value of the coin.

- (ix) a design that pays tribute to the Industrial Revolution in terms of transport and engineering. The coin features Brunel's ship 'SS Great Britain', together with his famous 'Box Tunnel'. Isambard Kingdom Brunel himself is depicted in the cameo. The inscriptions include 'Industrial Revolution' and the value of the coin.
- (x) a design featuring The Battle of Trafalgar in 1805, together with a cameo depicting a silhouette of Lord Nelson. The inscriptions include 'The Battle of Trafalgar' and the value of the coin.
- (xi) a design featuring Britannia with her trident and shield, sat atop a globe, together with a cameo of Queen Victoria. The inscriptions include 'The Age of Empire' and the value of the coin.
- (xii) a design featuring the famous image of Lord Kitchener taken from the classic recruitment posters of the time, together with a cameo depicting a soldier of World War I. The inscriptions include 'The First World War' and the value of the coin.

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
