GIBRALTAR COINAGE ACT, 1990

ISSUE OF THE COIN TO COMMEMORATE THE GUINEA – THE GREAT RECOINAGE NOTICE 2017

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following notice—

Title and commencement.

1. This notice may be cited as the Issue of the Coin to Commemorate the Guinea – The Great Recoinage Notice 2017 and shall be deemed to have come into operation on the 1st August 2016.

Issue of new coins.

- 2.(1) New coins of gold in the denominations of Quarter Guinea, Third Guinea, Half Guinea, One Guinea, Two Guineas and Five Guineas shall be made.
- (2) In the making of the said coins, the millesimal fineness or composition of metal, diameter, shape and other specifications shall be as set out in Part VIII of the Schedule to the Gibraltar Coinage Act, 1990.
- (3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins.

- 3. The design of the coins authorised by this notice shall be as follows
 - (a) the coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH II DEI GRA REGINA GIBRALTAR" bordering the top edge, and the year of the coin below;

- (b) the reverse impressions shall bear;
 - (i) Five Guineas a design depicting four crowned cruciform shields bearing the arms of England, Scotland, France, and Ireland, between which are four sceptres, and in the centre four interlinked "C"s. The words "THE GREAT RECOINAGE" are shown bordering the top; the denomination of the coin and the years 1816 and 2016 at the bottom;
 - (ii) Two Guineas a design depicting a single, large crowned shield with the quarters containing the arms of; England and Scotland, France, Hanover, and Ireland. The words "THE GREAT RECOINAGE" are shown bordering the top; the denomination of the coin and the years 1816 and 2016 at the bottom;
 - (iii) One Guinea a design depicting a single, spade-shaped, crowned shield with the quarters containing the arms of; England and Scotland, France, Hanover, and Ireland. The words "THE GREAT RECOINAGE" are shown bordering the top; the denomination of the coin and the years 1816 and 2016 at the bottom;
 - (iv) Half Guinea a design depicting a crowned shield within a Garter, with the words "HONI SOIT QUI MAL Y PENSE" on the Garter. The words "THE GREAT RECOINAGE" are shown bordering the top; the denomination of the coin and the years 1816 and 2016 at the bottom;
 - (v) Third Guinea a design depicting a single, large crown. The words "THE GREAT RECOINAGE" are shown bordering the top; the denomination of the coin and the years 1816 and 2016 at the bottom;
 - (vi) Quarter Guinea a design depicting four crowned cruciform shields bearing the arms of England, Scotland, France, and Ireland, between which are four sceptres, and a sun in the centre. The words "THE GREAT RECOINAGE" are shown bordering the top; the denomination of the coin and the years 1816 and 2016 at the bottom.

4. The said coins shall be current and legal tender in Gibraltar with effect from $1^{\rm st}$ August 2016.
