GIBRALTAR COINAGE ACT, 1990

**ISSUE OF THE PLATINUM WEDDING ANNIVERSARY
SOVEREIGN COLLECTION COINS NOTICE 2017**

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following notice-

Title and commencement.

1. This notice may be cited as the Issue of the Platinum Wedding Anniversary Sovereign Collection Coins Notice 2017 and shall come into operation on the day of publication.

Issue of new coins.

2.(1) New coins of gold in the denomination of a Quarter, Half, One, Two and Five Sovereigns shall be made.

(2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part VII of the Schedule to the Gibraltar Coinage Act, 1990.

(3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins.

3. The design of the coins authorised by this notice shall be as follows-

- (a) the coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH II DEI GRA REGINA GIBRALTAR" bordering the top edge, date of the year below;
- (b) the reverse impression of the Quarter Sovereign shall bear a design depicting a rendition of H.R.H Prince Philip's coat of

arms with the letters 'E' and 'P' in the 9 o'clock and 3 o'clock positions respectively;

- (c) the reverse impression of the Half Sovereign shall bear a design depicting a rendition of H.M Queen Elizabeth II's coat of arms with the letters 'E' and 'P' in the 9 o'clock and 3 o'clock positions respectively;
- (d) the reverse impression of the Sovereign shall bear the designs depicting a rendition of H.R.H Prince Philip's coat of arms alongside a rendition of H.M Queen Elizabeth II's coat of arms. Between the two coat of arms sits the Wedding Torch, a symbol associated with marriage.; and
- (e) the reverse impression of the Double Sovereign and the Five Sovereign shall bear the designs depicting a rendition of H.R.H Prince Philip's coat of arms alongside a rendition of H.M Queen Elizabeth II's coat of arms. Between the two coat of arms sits the Wedding Torch. The inscription reads 'STRENGTH & STAY' bordering the top and the years '1947 -2017' below.

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
