GIBRALTAR COINAGE ACT, 1990

ISSUE OF "CLASSICAL OLYMPICS" COIN NOTICE, 1990

In exercise of the powers conferred upon him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Governor has issued the following notice—

Title.

1. This notice may be cited as the "Classical Olympics" Coin Notice, 1990.

Issue of new coins.

2. (1) New coins of platinum, gold, palladium, silver and cupro nickel in the denomination of one Crown and thereof, shall be made.

(2) In the making of the said coins the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part 2 of the Schedule to the Gibraltar Coinage Act, 1990.

(3) In the making of the said coins a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Schedule.

Design of the coins.

3. The design of the coins authorised by this notice shall be as follows—

- (a) all coins shall bear in the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH II" to the left and the inscription "GIBRALTAR" and the date of the year to the right;
- (b) the reverse impression shall have the circumscription "XXV OLYMPIAD BARCELONA" with the value of the coin surrounding one of the following designs -
 - (i) Boxer resting, from a bronze statue by Appollonius of Athens, (1st Century BC.) Inset, Boxing match at Attic, from bowl, c.530BC;
 - (ii) Discobis by Myron (Roman Copy), (1st Century AD superimposed on discus thrown by Exdidas winner of contest m Kephallenia, with spiral inscription dedicated to Castor at Pollux (6th Century BC);
 - (iii) Winner of Javelin on the Podium, from inside of bowl, (c.510BC), in background. In the foreground, figure based on Poseidon (National Museum, Athens);
 - (iv) Bronze head of Wrestler wearing leather cap,(3rd Century BC). Superimposed on wrestler throwing - a flying mate, from a drinking cup, (c.450-425 BC);
 - (v) Long Distance Runners, adapted from amphora, (333BC);
 - (vi) Long Jumper landing in front of judge, from shoulder of storage jar, (c.575-550BC);
 - (vii) Chariot Racing, based on votive relief "Abduction of Basily by Echelos", (National Museum, Athens);
 - (viii) Olympic winner, based on bronze statue, of young man, found in the sea off Anticythera. (National Museum, Athens): -
