#### **GIBRALTAR COINAGE ACT 1990**

# GOLDEN WEDDING ANNIVERSARY OF HER MAJESTY QUEEN ELIZABETH II AND HIS ROYAL HIGHNESS PRINCE PHILIP CROWN COIN NOTICE 1997

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act 1990, and of all other enabling powers, the Governor has issued the following notice —

#### Title.

1. This notice may be cited as the Golden Wedding Anniversary of Her Majesty Queen Elizabeth II and His Royal Highness Prince Philip Crown Coin Notice 1997.

### Issue of new coins.

- 2. (1) New coins of platinum, gold, silver and cupro nickel in the denomination of a Crown and denominations thereof shall be made.
- (2) In the making of the said coins, the millesimal fineness, or composition of metals, diameters, shapes and other specifications shall be as set out in Part II of the Schedule to the Gibraltar Coinage Act 1990.
- (3) In the making of the said coins, a remedy (that is, a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

# Design of the coins.

- 3. The design of the coins authorised by this notice shall be as follows
  - (a) the coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH

II" to the left and the inscription "GIBRALTAR" and the date of the year to the right;

- (b) the reverse impression shall bear
  - (i) a portrait of Her Royal Highness the Princess Elizabeth and Lieutenant Philip Mountbatten on the occasion of their betrothal on 9th July 1947 together with the inscription "GOLDEN WEDDING ANNIVERSARY OF QUEEN ELIZABETH II AND PRINCE PHILIP" and the value of the coin; or
  - (ii) a portrait of Her Royal Highness the Princess Elizabeth with the infant Prince Charles of Edinburgh after his birth on 14th November 1948 together with the inscription "GOLDEN WEDDING ANNIVERSARY OF QUEEN ELIZABETH II AND PRINCE PHILIP" and the value of the coin; or
  - (iii) a portrait of Her Majesty Queen Elizabeth II with their Royal Highnesses Prince Charles and Princess Anne in Gibraltar in 1954 feeding the Apes together with the inscription "GOLDEN WEDDING ANNIVERSARY OF QUEEN ELIZABETH II AND PRINCE PHILIP" and the value of the coin; or
  - (iv) a portrait of Her Majesty Queen Elizabeth II at the time of Her Silver Jubilee in 1977, with a design of a flag-waving crowd in the background together with the inscription "GOLDEN WEDDING ANNIVERSARY OF QUEEN ELIZABETH II AND PRINCE PHILIP" and the value of the coin.

## 4. Legal tender.

The said coins shall be current and legal tender in Gibraltar.
