## GIBRALTAR COINAGE ACT, 1990

### ISSUE OF THE HARRY POTTER PART ONE CRESTS COINS NOTICE 2019

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and all other enabling powers, the Minister responsible for finance has issued the following Notice –

#### **Title.**

1. This Notice may be cited as the Issue of the Harry Potter Part One Crests Coins Notice 2019.

#### **Commencement.**

2. This Notice shall come into operation on the day of publication.

#### **Issue of new coins.**

3.(1) New coins of Cupro Nickel, Tombac, Silver and Gold in the denominations of a 1/25 Crown, ½ Crown, Crown, Double Crown, One Pound, Two Pounds, Five Pounds, Ten Pounds, Twenty Pounds, ¼ Sovereign, ½ Sovereign, Sovereign, Two Sovereigns and Five Sovereigns shall be made.

(2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Parts II, III and VII of the Schedule to the Gibraltar Coinage Act, 1990.

(3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Parts II, III and VII of the Schedule.

#### **Design of the coins.**

4. The designs of the coins authorised by this Notice shall be as follows –

- (a) the coins (save for the Sovereign coins as provided in subparagraph (b)) shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription “ELIZABETH II.D.G.REGINA.GIBRALTAR” bordering the top edge, date of the year below;

- (b) The Sovereign coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription “ELIZABETH II.DEL.GRA.REGINA.GIBRALTAR” bordering the top edge, date of the year below;
- (c) the reverse impression shall bear the Hogwarts School Crest, a design depicting the house mascots and colours. The inscription bordering the top edge reads “HARRY POTTER”;
- (d) the reverse impression shall bear a design depicting the Gryffindor House Crest. The inscription bordering the top edge reads “HARRY POTTER”;
- (e) the reverse impression shall bear a design depicting the Ravenclaw House Crest. The inscription bordering the top edge reads “HARRY POTTER”;
- (f) the reverse impression shall bear a design depicting the Slytherin House Crest. The inscription bordering the top edge reads “HARRY POTTER”; and
- (g) the reverse impression shall bear a design depicting the Hufflepuff House Crest. The inscription bordering the top edge reads “HARRY POTTER”.

**Legal Tender.**

5. The said coins shall be current and legal tender in Gibraltar.
