# ISSUE OF THE QUEEN VICTORIA'S 200<sup>TH</sup> ANNIVERSARY SOVEREIGN COLLECTION COINS NOTICE 2019

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and all other enabling powers, the Minister responsible for finance has issued the following Notice –

#### Title.

1. This Notice may be cited as the Issue of the Queen Victoria's 200<sup>th</sup> Anniversary Sovereign Collection Coins Notice 2019.

#### Commencement.

2. This Notice shall come into operation on the day of publication.

#### Issue of new coins.

- 3.(1) New coins of gold in the denominations of Quarter Sovereign, Half Sovereign, Sovereign, Two Sovereigns and Five Sovereigns shall be made.
- (2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part VII of the Schedule to the Gibraltar Coinage Act, 1990.
- (3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Part VII of the Schedule.

### Design of the coins.

- 4. The designs of the coins authorised by this Notice shall be as follows
  - (a) the coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH II DEI GRA REGINA GIBRALTAR" bordering the top edge, date of the year below;

- (b) the reverse impression shall bear a portrait of Queen Victoria alongside the Victoria and Albert privy mark;
- (c) the reverse impression shall bear a portrait of Prince Albert alongside the Victoria and Albert privy mark;
- (d) the reverse impression shall bear a conjoined portrait of Queen Victoria and Prince Albert alongside the Victoria and Albert privy mark;
- (e) the reverse impression shall bear a conjoined portrait of Queen Victoria and Prince Albert alongside the Victoria and Albert privy mark. An image of two dolphins is also depicted;
- (f) the reverse impression shall bear a conjoined portrait of Queen Victoria and Prince Albert alongside the Victoria and Albert privy mark. Images of two dolphins and a trident are also depicted; and
- (g) the reverse impression shall bear a conjoined portrait of Queen Victoria and Prince Albert alongside the Victoria and Albert privy mark. Images of two dolphins and a trident are also depicted. The inscription on the top edge of the coin reads "VICTORIA D:G: BRIT: REG: F:D: ALBERTUS PRINCEPS CONJUX". The inscription on the bottom edge of the coin reads "MDCCCLI".

## Legal Tender.

5. The said coins shall be current and legal tender in Gibraltar.
