GIBRALTAR COINAGE ACT, 1990

ISSUE OF CIRCULATING COINS NOTICE, 2020

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act 1990, and of all other enabling powers, the Minister Responsible for Finance has issued the following notice –

Title.

1. This notice may be cited as the Issue of Circulating Coins Notice, 2020.

Issue of new coins.

- 2.(1) New coins of cupro-nickel, copper plated steel, nickel brass, nickel plated steel and mixed metal in the denominations of 2 pounds, 50 pence, 20 pence, 10 pence, 5 pence, 2 pence and 1 pence shall be made.
- (2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part I of the Schedule to the Gibraltar Coinage Act 1990.
- (3) In the making of the said coins, a remedy (that is a variation from the standards weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins.

- 3. The design of the coins authorised by this notice shall be as follows
 - (a) the coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH II D G REGINA GIBRALTAR 2020" bordering the coins from left to right;
 - (b) the reverse impression of the 1 pence shall bear an image depicting Commonwealth Park. The inscription at the top of the coin reads "ONE PENNY" together with the value "1" inscribed below;
 - (c) the reverse impression of the 2 pence shall bear an image depicting the Small Boats Marina. The inscription at the top of the coin reads "TWO PENCE" together with the value "2" inscribed below;

- (d) the reverse impression of the 5 pence shall bear an image depicting Windsor Bridge. The inscription at the top of the coin reads "FIVE PENCE" together with the value "5" inscribed below;
- (e) the reverse impression of the 10 pence shall bear an image depicting a Barbary Partridge. The inscription at the top of the coin reads "TEN PENCE" together with the value "10" inscribed below;
- (f) the reverse impression of the 20 pence shall bear an image depicting a dolphin jumping out of the water, together with the Rock of Gibraltar in the background. The inscription at the top of the coin reads "TWENTY PENCE" together with the value "20" inscribed below;
- (g) the reverse impression of the 50 pence shall bear an image depicting the Skywalk. The inscription at the top of the coin reads "FIFTY PENCE" together with the value "50" inscribed below; and
- (h) the reverse impression of the 2 pounds shall bear an image depicting the Eastern Side of the Rock of Gibraltar, showing the beaches Sandy Bay, Catalan Bay and Eastern Beach. The inscription at the bottom of the coin reads "TWO POUNDS".

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
