GIBRALTAR COINAGE ACT, 1990

ISSUE OF THE REMEMBRANCE COLLECTION COIN NOTICE 2021

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice-

Title and commencement.

1. This Notice may be cited as the Issue of the Remembrance Collection Coin Notice 2021 and comes into operation on the day of publication.

Issue of new coins.

- 2.(1) New coins of gold and silver in the denominations of a quarter, half, one, double/two, quintuple/five sovereigns and ten pounds shall be made.
- (2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be set out in Parts VII and IX of the Schedule to the Gibraltar Coinage Act, 1990.
- (3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Parts of the Schedule.

Design of the coins.

- 3. The design of the coins authorised by this Notice shall be as follows
 - (a) the sovereign coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH II DEI GRA REGINA GIBRALTAR" bordering the top edge, date of the year below;
 - (b) the ten pound coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH II D.G REGINA. GIBRALTAR" bordering the top edge, date of the year and value shown below;
 - (c) the reverse design of the quarter sovereign depicts an image of soldiers marching across a battlefield. An image of some poppies is also depicted below;

- (d) the reverse design of the half sovereign depicts an image of a soldier kneeling down amidst some poppies at the graveside of fallen comrades;
- (e) the reverse design of the sovereign depicts an image of soldiers marching. A part image of a poppy is depicted in the background together with the inscription 'IN FLANDERS FIELDS THE POPPIES BLOW' shown below;
- (f) the reverse design of the double/two sovereign depicts an image of poppies overflowing from the Tower of London. The inscription at the top right reads 'BETWEEN THE CROSSES ROW ON ROW';
- (g) the reverse design of the quintuple/five sovereign depicts an image of a soldier, an RAF airwoman and a Royal Navy marine proudly wearing the symbol of remembrance close to their hearts. The inscription at the bottom edge reads 'WE WILL REMEMBER THEM';
- (h) the reverse design of the ten pound coin depicts an image of a soldier kneeling before a bed of poppies with his head bowed in respect to his fallen comrades. In the background there are soldiers ready for battle with poppies pushing through the muddy battlefield whilst military aircraft fly in the skies above. The inscription around the edge reads 'IN FLANDERS FIELDS THE POPPIES BLOW, BETWEEN THE CROSSES ROW ON ROW'.

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
