GIBRALTAR COINAGE ACT, 1990

ISSUE OF THE REIMAGINED GUINEA COLLECTION COIN NOTICE 2021

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice-

Title and commencement.

1. This Notice may be cited as the Issue of the Reimagined Guinea Collection Coin Notice 2021 and comes into operation on the day of publication.

Issue of new coins.

2.(1) New coins of silver in the denominations of a quarter, third, half, one, two and five guineas shall be made.

(2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part VIII of the Schedule to the Gibraltar Coinage Act, 1990.

(3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins.

3. The design of the coins authorised by this Notice shall be as follows-

- (a) the coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription "ELIZABETH II. D. G. REGINA GIBRALTAR 2021" bordering the edge;
- (b) the reverse impression of the quarter guinea shall bear a design depicting four crowned cruciform shields bearing the arms of England, Scotland, France and Ireland, between which are four Sceptres, and a sun in the centre. The inscription surrounding the edge of the coin reads 'BRITANNIARUM REG FIDEI DEFENSOR' and the value is shown below;

- (c) the reverse impression of the third guinea shall bear a design depicting a single, large crown. The inscription surrounding the edge of the coin reads 'BRITTANIARUM REG FIDEI DEFENSOR' and the value is shown below;
- (d) the reverse impression of the half guinea shall bear a design depicting a crowned shield within a Garter. The inscription on the garter reads 'HONI SOIT QUI MAL Y PENSE'. The inscription surrounding the edge of the coin reads 'BRITTANIARUM REG FIDEI DEFENSOR' and the value is shown below;
- (e) the reverse impression of the guinea shall bear a design depicting a single, spade-shaped, crowned shield with the quarters containing the arms of England and Scotland, France, Hanover and Ireland. The inscription surrounding the edge of the coin reads 'BRITTANIARUM REG FIDEI DEFENSOR' and the value is shown below;
- (f) the reverse impression of the two guineas shall bear a design depicting a single, large crown shield with quarters containing the arms of England and Scotland, France, Hanover and Ireland. The inscription surrounding the edge of the coin reads 'BRITTANIARUM REG FIDEI DEFENSOR' and the value is shown below;
- (g) the reverse impression of the quarter guinea shall bear a design depicting four crowned cruciform shields bearing the arms of England, Scotland, France and Ireland, between which are four Sceptres. The inscription surrounding the edge of the coin reads 'BRITTANIARUM REG FIDEI DEFENSOR' and the value is shown below.

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
