GIBRALTAR COINAGE ACT, 1990

ISSUE OF THE SEVEN SIGNATORIES – IRISH PROCLAMATION OF INDEPENDENCE - PART 2 - COINS NOTICE 2022

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice—

Title and commencement.

1. This Notice may be cited as the Issue of the Seven Signatories – Irish Proclamation of Independence - Part 2 - Coins Notice 2022 and comes into operation on the day of publication.

Issue of new coins.

- 2.(1) New coins of gold in the denomination of 1/25 crown, shall be made.
- (2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part II of the Schedule to the Gibraltar Coinage Act, 1990.
- (3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule

Design of the coins.

- 3. The design of the coins authorised by this notice shall be as follows
 - (a) the coins shall bear on the obverse impression the Gibraltar Coat of Arms with the inscription "ELIZABETH II D G REGINA GIBRALTAR" bordering the edge, date of year and value shown below;
 - (b) the reverse impression shall bear a portrait image of Thomas Clarke. The inscription on the left edge reads 'THOMAS CLARK';
 - (c) the reverse impression shall bear a portrait image of Sean Mac Diarmada. The inscription on the right edge reads 'SEAN MAC DIARMADA';
 - (d) the reverse impression shall bear a portrait image of Thomas MacDonagh. The inscription on the left edge reads 'THOMAS MACDONAGH';

- (e) the reverse impression shall bear a portrait image of Padraig Pearse. The inscription on the right edge reads 'PADRAIG PEARSE';
- (f) the reverse impression shall bear a portrait image of Eamonn Ceannt. The inscription on the left edge reads 'EAMONN CEANNT';
- (g) the reverse impression shall bear a portrait image of James Connolly. The inscription on the left edge reads 'JAMES CONNOLLY';
- (h) the reverse impression shall bear a portrait image of Joseph Plunkett. The inscription on the right edge reads 'JOSEPH PLUNKETT'.

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
