GIBRALTAR COINAGE ACT, 1990

ISSUE OF THE PRINCE WILLIAM 40TH BIRTHDAY COLLECTION COINS NOTICE 2022

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice—

Title and commencement.

1. This Notice may be cited as the Issue of the Prince William 40th Birthday Collection Coins Notice 2022 and comes into operation on the day of publication.

Issue of new coins.

2.(1) New coins of gold in the denominations of ¼ Sovereign, Sovereign and five /quintuple Sovereign shall be made.

(2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part VII of the Schedule to the Gibraltar Coinage Act, 1990.

(3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins.

3. The design of the coins authorised by this Notice shall be as follows –

- (a) the coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription ‘ELIZABETH II DEI.GRA REGINA GIBRALTAR’ bordering the top edge, date of the year below;
- (b) the reverse impression of the quarter sovereign shall depict a design of his Royal Highness Prince William’s Royal Coat of Arms with the inscription ‘HIS ROYAL HIGHNESS PRINCE WILLIAM DUKE OF CAMBRIDGE’ alongside a ‘40’ to mark the duke’s 40th birthday;
- (c) the reverse impression of the sovereign shall depict a design of his Royal Highness Prince William’s Royal Coat of Arms with the inscription ‘HIS ROYAL

HIGHNESS PRINCE WILLIAM DUKE OF CAMBRIDGE' alongside a '40' to mark the duke's 40th birthday. Below the Coat of Arms is a ribbon which features the Spencer Family motto 'DIEU DEFEND LE DROIT';

- (d) the reverse impression of the five/quintuple sovereign shall depict a design of his Royal Highness Prince William's Royal Coat of Arms with the inscription 'HIS ROYAL HIGHNESS PRINCE WILLIAM DUKE OF CAMBRIDGE' alongside a '40' to mark the duke's 40th birthday. Below the Coat of Arms is a ribbon which features the Spencer Family motto 'DIEU DEFEND LE DROIT'. The inscription encircling the design reads 'HONI SOIT QUI MAL Y PENSE'.

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
