GIBRALTAR COINAGE ACT, 1990

ISSUE OF THE QUEEN ELIZABETH II PLATINUM JUBILEE THEN & NOW COLLECTION PART 3 COINS NOTICE 2022

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice—

Title and commencement.

1. This Notice may be cited as the Issue of the Queen Elizabeth II Platinum Jubilee Then & Now Collection – Part 3 Coins Notice 2022 and comes into operation on the day of publication.

Issue of new coins.

- 2.(1) New coins of cupro nickel, silver, gold and platinum in the denominations of 1/25 Crown, Half Crown, Crown, Double/Two Crowns, Ten pounds, Twenty Five Pounds, Hundred Pounds and one sovereign shall be made.
- (2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Parts II, VII and IX of the Schedule to the Gibraltar Coinage Act, 1990.
- (3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Parts of the Schedule.

Design of the coins.

- 3. The design of the coins authorised by this Notice shall be as follows
 - (a) the coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription 'ELIZABETH II D.G. REGINA GIBRALTAR' bordering the top edge, date of the year and value below;
 - (b) the sovereign coin shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription 'ELIZABETH II. DEI. GRA REGINA. GIBRALTAR' bordering the edge, date of the year below;
 - (c) the reverse design shall bear a 'then' and 'now' portrait of Her Majesty Queen Elizabeth II. The portraits are divided by a sceptre with St Edward's crown featured at the top and the shield of the Royal Coat of Arms with sprigs of oak at

the bottom. The inscription reads 'I DECLARE BEFORE YOU ALL THAT MY WHOLE LIFE WHETHER IT BE LONG OR SHORT SHALL BE DEVOTED TO YOUR SERVICE AND THE SERVICE OF OUR GREAT IMPERIAL FAMILY TO WHICH WE ALL BELONG';

- (d) the reverse designs shall bear photographic images of Her Majesty Queen Elizabeth II 'then' and 'now', from the early days of her reign to more recent times. The photographs are divided by a sceptre entwined with sprigs of oak, with St Edward's crown featured at both ends and the shield of the Royal Coat of Arms in the centre. The inscription reads 'I DECLARE BEFORE YOU ALL THAT MY WHOLE LIFE WHETHER IT BE LONG OR SHORT SHALL BE DEVOTED TO YOUR SERVICE AND THE SERVICE OF OUR GREAT IMPERIAL FAMILY TO WHICH WE ALL BELONG';
- (e) the reverse design shall bear a remastering of the first coin portrait of Her Majesty the Queen. The inscription surrounding the edge reads 'HER MAJESTY QUEEN ELIZABETH II. PLATINUM JUBILEE.'

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
