## **GIBRALTAR COINAGE ACT, 1990**

#### ISSUE OF THE REMEMBRANCE COLLECTION COINS NOTICE 2022

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice—

#### Title and commencement.

1. This Notice may be cited as the Issue of the Remembrance Collection Coins Notice 2022 and comes into operation on the day of publication.

#### Issue of new coins.

- 2.(1) New coins of cupro nickel and gold in the denominations of a Quarter, Half, One, Double/Two, Five/Quintuple Sovereigns and One Crown shall be made.
- (2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Parts II and VII of the Schedule to the Gibraltar Coinage Act, 1990.
- (3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Parts of the Schedule.

### Design of the coins.

- 3. The design of the coins authorised by this Notice shall be as follows
  - (a) the sovereign coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription 'ELIZABETH. II. DEI. GRA REGINA GIBRALTAR' bordering the top edge, date of the year below;
  - (b) the crown coins shall bear on the obverse impression the effigy of Her Majesty Queen Elizabeth II with the inscription 'ELIZABETH II. D.G. REGINA. GIBRALTAR' bordering the top edge, date of the year and value below;
  - (c) the reverse design of the quarter sovereign depicts an image of Queen Elizabeth II laying a poppy wreath at the foot of the Cenotaph in the annual Remembrance Ceremony. The inscription at the top left reads 'LEST WE FORGET, WE WILL REMEMBER THEM';

- (d) the reverse design of the half sovereign depicts an image of a veteran looking through old military photographs. The inscription at the top edge reads 'LEST WE FORGET, WE WILL REMEMBER THEM';
- (e) the reverse design of the sovereign depicts an image of a hand laying a rose on top of a tombstone. The inscription on the tombstone reads 'LEST WE FORGET, WE WILL REMEMBER THEM';
- (f) the reverse design of the double/two sovereigns depicts an image of three representatives of the armed forces in front of a memorial wall with plaques and poppy wreaths. The inscription at the top edge reads 'LEST WE FORGET, WE WILL REMEMBER THEM';
- (g) the reverse design of the five/quintuple sovereigns depicts an image of the hand of a soldier holding the hand of a child. The inscription on the right side of the image reads 'LEST WE FORGET, WE WILL REMEMBER THEM';
- (h) the reverse design of the crown depicts an image of Queen Elizabeth II laying a poppy wreath at the foot of the Cenotaph in the annual Remembrance Ceremony. The inscription along the edge reads 'LEST WE FORGET, WE WILL REMEMBER THEM';
- (i) the reverse design of the crown depicts an image of the hand of a soldier holding the hand of a child. The inscription on the right edge reads 'LEST WE FORGET, WE WILL REMEMBER THEM'.

## Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
