GIBRALTAR COINAGE ACT, 1990

ISSUE OF THE VENETIAN ZODIAC COLLECTION COINS NOTICE 2022

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice—

Title and commencement.

1. This Notice may be cited as the Issue of the Venetian Zodiac Collection Coins Notice 2022 and comes into operation on the day of publication.

Issue of new coins.

2.(1) New coins of brass in the denomination of ½ Crown shall be made.

(2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part II of the Schedule to the Gibraltar Coinage Act, 1990.

(3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins.

3. The design of the coins authorised by this Notice shall be as follows –

- (a) the coins shall bear on the obverse impression the Gibraltar Coat of Arms with the inscription ‘ELIZABETH II . D . G . REGINA . GIBRALTAR . 2022’ bordering the edge and value shown below;
- (b) the reverse impression shall bear a design depicting the symbol of the Capricorn Zodiac sign. The inscription above the symbol reads ‘CAPRICORN’ and the inscription below reads ‘22 DEC – 19 JAN’;
- (c) the reverse impression shall bear a design depicting the symbol of the Aquarius Zodiac sign. The inscription above the symbol reads ‘AQUARIUS’ and the inscription below reads ‘20 JAN – 18 FEB’;

- (d) the reverse impression shall bear a design depicting the symbol of the Pisces Zodiac sign. The inscription above the symbol reads 'PISCES' and the inscription below reads '19 FEB – 20 MAR';
- (e) the reverse impression shall bear a design depicting the symbol of the Aries Zodiac sign. The inscription above the symbol reads 'ARIES' and the inscription below reads '21 MAR – 19 APR';
- (f) the reverse impression shall bear a design depicting the symbol of the Taurus Zodiac sign. The inscription above the symbol reads 'TAURUS' and the inscription below reads '20 APR – 20 MAY';
- (g) the reverse impression shall bear a design depicting the symbol of the Gemini Zodiac sign. The inscription above the symbol reads 'GEMINI' and the inscription below reads '21 MAY – 20 JUN';
- (h) the reverse impression shall bear a design depicting the symbol of the Cancer Zodiac sign. The inscription above the symbol reads 'CANCER' and the inscription below reads '21 JUN– 22 JUL';
- (i) the reverse impression shall bear a design depicting the symbol of the Leo Zodiac sign. The inscription above the symbol reads 'LEO' and the inscription below reads '23 JUL– 22 AUG';
- (j) the reverse impression shall bear a design depicting the symbol of the Virgo Zodiac sign. The inscription above the symbol reads 'VIRGO' and the inscription below reads '23 AUG– 22 SEPT';
- (k) the reverse impression shall bear a design depicting the symbol of the Libra Zodiac sign. The inscription above the symbol reads 'LIBRA' and the inscription below reads '23 SEPT– 22 OCT';
- (l) the reverse impression shall bear a design depicting the symbol of the Scorpio Zodiac sign. The inscription above the symbol reads 'SCORPIO' and the inscription below reads '23 OCT – 21 NOV';
- (m) the reverse impression shall bear a design depicting the symbol of the Sagittarius Zodiac sign. The inscription above the symbol reads 'SAGITTARIUS' and the inscription below reads '22 NOV – 21 DEC'.

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
