GIBRALTAR COINAGE ACT, 1990

ISSUE OF THE END & BEGINNING OF AN ERA COLLECTION COINS NOTICE 2022

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice—

Title and commencement.

1. This Notice may be cited as the Issue of the End & Beginning of an Era Collection Coins Notice 2022 and comes into operation on the day of publication.

Issue of new coins.

- 2.(1) New coins of cupro nickel, silver and gold in the denominations of a 1/25, ½, crown, two/double crowns, ten pounds, twenty- five pounds, 100 Pounds, ¼ Sovereign, ½ Sovereign, one Sovereign, double Sovereign and quintuple Sovereign shall be made.
- (2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Parts II, VII and IX of the Schedule to the Gibraltar Coinage Act, 1990.
- (3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Parts of the Schedule.

Design of the coins.

- 3. The design of the coins authorised by this Notice shall be as follows
 - (a) the sovereign coins shall bear on the obverse impression the effigy of His Majesty King Charles III with the inscription "CHARLES III. DEI. GRA. REX. F.D. GIBRALTAR" bordering the top edge, date of the year below;
 - (b) the crown and pound coins shall bear on the obverse impression the effigy of His Majesty King Charles III with the inscription "CHARLES III. D.G. REX. F.D. GIBRALTAR" bordering the top edge, date of the year and value below;
 - (c) the reverse design features a portrait of Her late Majesty Queen Elizabeth II looking right whilst a portrait of His Majesty King Charles III looks left. The portraits are divided by the crown jewels, St Edward's coronation crown, the

Sovereign's sceptre, and Sovereign's orb – to represent the transition from one monarch to the next. At the bottom of the design are sprigs of oak, inspired by the House of Windsor crest – which symbolise strength and longevity. The inscription that surrounds the design reads, "IT IS MY SINCERE WISH THAT THE COMMONWEALTH WILL CONTINUE TO OFFER STABILITY AND CONTINUITY FOR FUTURE GENERATIONS".

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
