GIBRALTAR COINAGE ACT, 1990

ISSUE OF THE POLISH QUEENS COLLECTION COINS NOTICE 2023

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice—

Title and commencement.

1. This Notice may be cited as the Issue of the Polish Queens Collection, Coins Notice 2023 and comes into operation on the day of publication.

Issue of new coins.

2.(1) New coins of gold in the denominations of 1/10 and 1/25 Crown shall be made.

(2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part II of the Schedule to the Gibraltar Coinage Act, 1990.

(3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins.

3. The design of the coins authorised by this Notice shall be as follows –

- (a) the obverse design features the Gibraltar Coat of Arms, with the inscription “ELIZABETH II D G REGINA GIBRALTAR” bordering the edge, together with the date of year and value;
- (b) the reverse design depicts a portrait of Queen Jadwiga Andegawska designed by the artist Rossana Alex-Nowakowska with the inscription “REGINA POLONIAE”;
- (c) the reverse design depicts a portrait of Queen Zofia Holszanska designed by the artist Rossana Alex-Nowakowska with the inscription “REGINA POLONIAE”;
- (d) the reverse design depicts a portrait of Queen Bona Sforza designed by the artist Rossana Alex-Nowakowska with the inscription “REGINA POLONIAE”;

- (e) the reverse design depicts a portrait of Queen Barbara Radziwillowna designed by the artist Rossana Alex-Nowakowska with the inscription “REGINA POLONIAE”;
- (f) the reverse design depicts a portrait of Queen Ludwika Maria Gonzaga designed by the artist Rossana Alex-Nowakowska with the inscription “REGINA POLONIAE”;
- (g) the reverse design depicts a portrait of Queen Anna Jagiellonka designed by the artist Rossana Alex-Nowakowska with the inscription “REGINA POLONIAE”;
- (h) the reverse design depicts a portrait of Queen Maria Kazimiera D’Arquien designed by the artist Rossana Alex-Nowakowska with the inscription “REGINA POLONIAE”;
- (i) the reverse design depicts a portrait of Queen Dobrawa Przemyslidka designed by the artist Rossana Alex-Nowakowska with the inscription “REGINA POLONIAE”.

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
