GIBRALTAR COINAGE ACT, 1990

ISSUE OF THE ELVIS GREATEST HITS COLLECTION PART ONE, COINS NOTICE 2023

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice—

Title and commencement.

1. This notice may be cited as the Issue of the Elvis Greatest Hits Collection Part One, Coins Notice 2023 and shall come into operation on the day of publication.

Issue of new coins.

- 2.(1) New coins of cupro nickel and gold in the denominations of one Crown and two Crowns shall be made.
- (2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part II of the Schedule to the Gibraltar Coinage Act, 1990.
- (3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins.

- 3. The design of the coins authorised by this notice shall be as follows
 - (a) the obverse design features the Gibraltar Coat of Arms, with the inscription "CHARLES III D G REX F D GIBRALTAR" bordering the edge, together with the date of year and value;
 - (b) the reverse design features an iconic image of the King of Rock'n'roll surrounded by the musical iconography "RETURN TO SENDER" and Elvis Presley's autograph. The struck section of the coin depicts a music staff with ribbons down the left-hand side towards the hand, holding the iconic 1960's microphone. At the bottom centre of the coin, half a vinyl is shown with official Elvis Presley signature;
 - (c) the reverse design features an iconic image of the King of Rock'n'roll surrounded by the musical iconography "SUSPICIOUS MINDS" and Elvis Presley's autograph.

The struck section of the coin depicts a music staff with ribbons down the left-hand side towards the hand, holding the iconic 1960's microphone. At the bottom centre of the coin, half a vinyl is shown with official Elvis Presley signature;

- (d) the reverse design features an iconic image of the King of Rock'n'roll surrounded by the musical iconography "LOVE ME TENDER" and Elvis Presley's autograph. The struck section of the coin depicts a music staff with ribbons down the left-hand side towards the hand, holding the iconic 1960's microphone. At the bottom centre of the coin, half a vinyl is shown with official Elvis Presley signature;
- (e) the reverse design features an iconic image of the King of Rock'n'roll surrounded by the musical iconography "MEMORIES" and Elvis Presley's autograph. The struck section of the coin depicts a music staff with ribbons down the left-hand side towards the hand, holding the iconic 1960's microphone. At the bottom centre of the coin, half a vinyl is shown with official Elvis Presley signature;
- (f) the reverse design features an iconic image of the King of Rock'n'roll surrounded by the musical iconography "BURNING LOVE" and Elvis Presley's autograph. The struck section of the coin depicts a music staff with ribbons down the left-hand side towards the hand, holding the iconic 1960's microphone. At the bottom centre of the coin, half a vinyl is shown with official Elvis Presley signature;
- (g) the reverse impression shall bear a design depicting an image of Elvis Presley alongside his name "ELVIS" and his iconic signature. The inscription around the border reads "BLUE SUEDE SHOES".

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
