GIBRALTAR COINAGE ACT, 1990

ISSUE OF THE ELVIS GREATEST HITS COLLECTION PART TWO, COINS NOTICE 2023

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice—

Title and commencement.

1. This notice may be cited as the Issue of the Elvis Greatest Hits Collection Part Two, Coins Notice 2023 and shall come into operation on the day of publication.

Issue of new coins.

2.(1) New coins of cupro nickel, silver and gold in the denominations of 1/10 crown, 1/5 crown, ¼ crown, ½ crown, one crown, ten crowns and ten pounds shall be made.

(2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Part II and Part IX of the Schedule to the Gibraltar Coinage Act, 1990.

(3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins.

3. The design of the coins authorised by this notice shall be as follows –

- (a) the obverse design features the Gibraltar Coat of Arms, with the inscription “CHARLES III D G REX F D GIBRALTAR” bordering the edge, together with the date of year and value;
- (b) the reverse design of this official fractional set, handpicked by Graceland, depicts an image of Elvis Presley in his most natural surroundings. The inscription around the border reads “THE KING OF ROCK ‘N’ ROLL” and the official Elvis Presley signature is also featured;
- (c) the reverse design of this official fractional set, handpicked by Graceland, depicts an image of Elvis Presley in the recording studio. The inscription around the border

reads “THE KING OF ROCK ‘N’ ROLL” and the official Elvis Presley signature is also featured;

(d) the reverse design of this official fractional set, handpicked by Graceland, depicts an image of Elvis Presley on stage performing. The inscription around the border reads “THE KING OF ROCK ‘N’ ROLL” and the official Elvis Presley signature is also featured;

(e) the reverse design of this official fractional set, handpicked by Graceland, depicts an image of Elvis Presley in the films. The inscription around the border reads “THE KING OF ROCK ‘N’ ROLL” and the official Elvis Presley signature is also featured.

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
