ISSUE OF THE TUTANKHAMUN 100TH COLLECTION COINS NOTICE 2023

In exercise of the powers conferred on him by section 2 of the Gibraltar Coinage Act, 1990, and of all other enabling powers, the Minister responsible for finance has issued the following Notice—

Title and commencement.

1. This Notice may be cited as the Issue of The Tutankhamun 100th Collection Coins Notice 2023 and comes into operation on the day of publication.

Issue of new coins.

- 2.(1) New coins of cupro nickel, silver and gold in the denominations of 1/25, 1/10, $\frac{1}{2}$, 1, two/double crowns and one pound shall be made.
- (2) In the making of the said coins, the millesimal fineness or composition of metals, diameters, shapes and other specifications shall be as set out in Parts II and IX of the Schedule to the Gibraltar Coinage Act, 1990.
- (3) In the making of the said coins, a remedy (that is a variation from the standard weight) shall be allowed as set out in the said Part of the Schedule.

Design of the coins.

- 3. The design of the coins authorised by this Notice shall be as follows
 - (a) the coins shall bear on the obverse impression the Gibraltar Coat of Arms encircled with the inscription "CHARLES III D G REX F D GIBRALTAR" together with the date of year and value below;
 - (b) the coins shall bear on the reverse impression a design depicting an image of Tutankhamun's Death Mask. The inscription encircling the image reads "100TH ANNIVERSARY DISCOVERY OF TUTANKHAMUN'S TOMB";
 - (c) the coins shall bear on the reverse impression a design depicting an image of Tutankhamun's Death Mask with the Horus Falcon below. The inscription encircling the image reads "100TH ANNIVERSARY DISCOVERY OF TUTANKHAMUN'S TOMB";

(d) the coins shall bear on the reverse impression a design depicting an image of Tutankhamun's Death Mask together with the images of Horus and Anubis on

each side. The inscription below reads "TUTANKHAMUN 100";

(e) the coins shall bear on the reverse impression a design depicting an image of

Tutankhamun sitting on his throne. The inscription below reads "THE THRONE";

(f) the coins shall bear on the reverse impression a design depicting an image of Horus and the Horus Falcon with hieroglyphics featuring in the background. The

inscription above the falcon reads "HORUS";

(g) the coins shall bear on the reverse impression a design depicting an image of Anubis and a statue of an Egyptian jackal on a tomb. Hieroglyphics are featured

in the background and the inscription above the jackal reads "ANUBIS";

(i) the coins shall bear on the reverse impression a design depicting an image of three

ancient Egyptians in the Valley of the Kings. The inscription above the image reads "THE VALLEY OF THE KINGS";

(j) the coins shall bear on the reverse impression an image of Tutankhamun's Death

Mask;

(k) the coins shall bear on the reverse impression a design depicting an image of

Tutankhamun's Death Mask, Anubis and a statue of an Egyptian jackal on a tomb.

Hieroglyphics are also featured in the background.

Legal Tender.

4. The said coins shall be current and legal tender in Gibraltar.
